# SUPPLEMENTAL DECLARATION OF ERIC KULJU IN SUPPORT OF THE APPLICATION OF DEBTORS FOR INTERIM AND FINAL ORDERS AUTHORIZING THE DEBTORS TO RETAIN AND EMPLOY DELOITTE & TOUCHE LLP AS INDEPENDENT AUDITOR NUNC PRO TUNC TO THE PETITION DATE

Pursuant to Rule 2014(a) of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), I, Eric Kulju, under penalty of perjury, declare as follows:

- 1. I am a partner of Deloitte & Touche LLP ("Deloitte & Touche"), which has an office at 555 East Wells Street, Suite 1400, Milwaukee, Wisconsin 53202. I am duly authorized to make and submit this supplemental declaration (the "Declaration") on behalf of Deloitte & Touche to supplement the disclosures contained in my initial declaration (the "Initial Declaration"), attached as Exhibit A to the Application of Debtors for Interim and Final Orders Authorizing the Debtors to Retain and Employ Deloitte & Touche LLP as Independent Auditor as of the Petition Date [Docket No. 34] (the "Application"). On July 20, 2020, this Court entered an order provisionally granting the Application [Docket No. 76].
- 2. I previously submitted the Initial Declaration in support of the Application.

  As discussed in paragraph 6 of the Initial Declaration, I stated that Deloitte & Touche would file

a supplement to the Initial Declaration to disclose any connections and relationships Deloitte & Touche and/or its affiliates may have with respect to the Debtors, the Debtors' affiliates, or any Potential Parties in Interest (defined below), as required by Bankruptcy Rule 2014(a).

3. Accordingly, by this Declaration, I am supplementing the statements set forth in the Initial Declaration to address Deloitte Tax's disinterestedness. The statements set forth in this Declaration are based upon my personal knowledge, information and belief, and/or client matter records kept in the ordinary course of business that were reviewed by me or other personnel of Deloitte & Touche or its affiliates.

#### **Disinterestedness**

- 4. Subject to the foregoing, except as set forth herein and in the attachments hereto, to the best of my information, knowledge, and belief based on reasonable inquiry: (a) neither I, Deloitte & Touche, nor any partner, principal, or managing director of Deloitte & Touche that is anticipated to provide the services for which Deloitte & Touche is to be retained (the "Engagement Partners/Principals/Managing Directors") holds any interest adverse to the Debtors; and (b) Deloitte & Touche has no relationship to the Debtors, their significant creditors, certain other significant parties-in-interest, or to the attorneys that are known to be assisting the Debtors in the chapter 11 cases, except as stated herein or in any attachment hereto.
- 5. In connection with Deloitte & Touche's retention by the Debtors in the chapter 11 cases, Deloitte & Touche undertook searches to determine, and to disclose, whether it or its affiliates is or has been employed by or has other relationships with the Debtors or their affiliates, subsidiaries, directors, or officers, or any of the Debtors' significant creditors, customers, equity security holders, professionals, or other entities with significant relationships with the Debtors (the "Potential Parties-in-Interest"), whose specific names were provided to Deloitte &

Touche by the Debtors, listed on <u>Schedule 1</u> attached hereto. To check upon and disclose possible relationships with significant Potential Parties-in-Interest in the chapter 11 cases, Deloitte & Touche researched its client databases and performed reasonable due diligence to determine whether it or its affiliates had any relationships with the Debtors or significant Potential Parties-in-Interest.

- 6. Deloitte & Touche and its affiliates have relationships with thousands of clients, some of which may be creditors of the Debtors or other Potential Parties-in-Interest. Accordingly, Deloitte & Touche and/or its affiliates have had, currently have and/or may have in the future banking or other relationships with such parties, or provided, may currently provide, and/or may provide in the future professional services to certain of these parties in matters unrelated to the chapter 11 cases. From time to time, Deloitte & Touche and its affiliates have provided or may currently provide services, and likely will continue to provide services, to certain creditors of the Debtors and various other parties potentially adverse to the Debtors in matters unrelated to the chapter 11 cases, except as set forth herein or in the attachments hereto. Additionally, certain significant Potential Parties-in-Interest have or may have provided goods or services, may currently provide goods or services, and/or may in the future provide goods or services to Deloitte & Touche and/or its affiliates and the Engagement Partners/Principals/Managing Directors in matters unrelated to the chapter 11 cases. A listing of parties with connections to Deloitte & Touche and/or its affiliates is attached to this Declaration as Schedule 2.
- 7. Deloitte & Touche believes that the relationships described herein or reflected on **Schedule 2** have no bearing on the services for which Deloitte & Touche's retention is being sought by the Debtors in the chapter 11 cases. Furthermore, such relationships do not

impair Deloitte & Touche's disinterestedness, and Deloitte & Touche does not represent an adverse interest in connection with the chapter 11 cases.

- 8. Despite the efforts described above to identify and disclose Deloitte & Touche's connections with the significant Potential Parties-in-Interest in the chapter 11 cases, because Deloitte & Touche is a nationwide firm with many employees, Deloitte & Touche is unable to state with certainty that every client relationship or other connection has been disclosed. In this regard, if Deloitte & Touche discovers additional material information that it determines requires disclosure, it will file a supplemental disclosure promptly with the Court.
- 9. To the best of my knowledge, based on the internal search discussed above, Deloitte & Touche has determined that certain relationships should be disclosed as follows:
  - a. Deloitte & Touche and/or its affiliates provide services in matters unrelated to the chapter 11 cases to certain of the Debtors' largest unsecured creditors and other Potential Parties-in-Interest or their affiliates listed on **Schedule 2**.
  - b. Law firms identified on <a href="Schedule 2">Schedule 2</a>, including Arnold & Porter Kaye Scholer LLP; Baker & McKenzie LLP; Baker & McKenzie, Australia; Blake, Cassels & Graydon LLP (Ontario, Canada); Bond, Schoeneck & King PLLC; Davis Wright Tremaine LLP; Duane Morris LLP; Faegre Drinker Biddle & Reath LLP; Foley & Lardner LLP; Ford & Harrison LLP; Fox Rothschild LLP; Gibson Dunn & Crutcher LLP; Godfrey & Kahn, S.C.; Gordon & Rees LLP; King & Spalding LLP; Kirkland & Ellis LLP; Latham & Watkins LLP; Littler Mendelson, P.C.; Loeb & Loeb; McCarter & English, LLP; McElroy Deutsch Mulvaney & Carpenter LLP; Ogletree Deakins Nash Smoak & Stewart, P.C.; Perkins Coie LLP; Pryor Cashman LLP; Quarles & Brady LLP; Reed Smith LLP; Weil, Gotshal & Manges LLP; and White & Williams LLP, have provided, currently provide and may in the future provide legal services to Deloitte & Touche or its affiliates in matters unrelated to the chapter 11 cases, and/or Deloitte & Touche or its affiliates have provided, currently provide and may in the future provide services to such firms or their clients.
  - c. In the ordinary course of its business, Deloitte & Touche and its affiliates have business relationships in unrelated matters with its principal competitors, which together with their affiliates may be Potential Parties-in-Interest in the chapter 11 cases. For example, from time to time, Deloitte & Touche and one or more of such entities may work on assignments for the same client or may otherwise engage each other for various purposes.

- d. Certain financial institutions or their respective affiliates (including AIG International; American International Group, Inc. (AIG); Bank of America, N.A.; BB&T Securities, LLC; BofA Securities, Inc.; CIBC Bank USA; Citibank N.A.; Comerica Bank; JPMorgan Chase Bank, N.A.; KeyBank National Association; National Union Fire Insurance Company of Pittsburgh, PA; SunTrust; U.S. Bank; Voya Insurance & Annuity Co.; and Wells Fargo Bank) listed on <a href="Schedule 2">Schedule 2</a> (i) are lenders to an affiliate of Deloitte & Touche (Deloitte & Touche is a guarantor of such indebtedness) and/or (ii) have financed a portion of the capital and/or capital loan requirements of various partners and principals, respectively, of Deloitte & Touche and its affiliates. In addition, certain institutions or their respective affiliates, including BlackRock, Inc.; Dimensional Fund Advisors, LP; Goldman Sachs & Co. LLC; Invesco; J.P. Morgan Securities LLC; and Vanguard, provide asset management services for, and/or have a similar role with respect to investments of, certain pension, benefit and similar funds sponsored by affiliates of Deloitte & Touche.
- e. Deloitte Tax and/or its affiliates have performed and currently perform certain professional services to BlackRock, Inc., a significant equity holder of the Debtors, in matters unrelated to these chapter 11 cases.
- f. Certain Potential Parties-in-Interest may be adverse to and/or involved in litigation matters with Deloitte & Touche or its affiliates in connection with matters unrelated to the chapter 11 cases.
- g. Deloitte Consulting LLP ("<u>Deloitte Consulting</u>"), an affiliate of Deloitte & Touche, and certain of its affiliates, have provided and will continue to provide services to the Executive Office of the United States Trustee in matters unrelated to the chapter 11 cases.
- 10. Furthermore, through reasonable inquiry, I do not believe there is any connection between the personnel of Deloitte & Touche or its affiliates who are anticipated to provide services to the Debtors and the United States Bankruptcy Judge presiding in the chapter 11 cases, the U.S. Trustee for Region 13, the Assistant United States Trustee for the Eastern District of Missouri, and the attorney therefor assigned to the chapter 11 cases.
- 11. Except as may be disclosed herein, to the best of my knowledge, information, and belief, Deloitte & Touche and the Engagement Partners/Principals/Managing Directors do not hold or represent any interest adverse to the Debtors, and I believe that Deloitte & Touche is a "disinterested person" as that term is defined in section 101(14) of the Bankruptcy
