**SECOND SUPPLEMENTAL DECLARATION OF RONIT J. BERKOVICH  
IN SUPPORT OF APPLICATION OF DEBTORS FOR AUTHORITY TO RETAIN  
AND EMPLOY WEIL, GOTSHAL & MANGES LLP AS ATTORNEYS FOR THE  
DEBTORS EFFECTIVE AS OF THE PETITION DATE PURSUANT TO  
11 U.S.C. §§ 327, 329, AND 504 AND FED. R. BANKR. 2014(a) AND 2016(b)**

I, Ronit J. Berkovich, pursuant to 28 U.S.C. § 1746, hereby declare that the following is true and correct to the best of my knowledge, information and belief:

1. I am a member of the firm of Weil, Gotshal & Manges LLP (“**Weil**” or the “**Firm**”), an international law firm with principal offices at 767 Fifth Avenue, New York, New York 10153 and regional offices in Washington, D.C.; Houston and Dallas, Texas; Miami, Florida; Boston, Massachusetts; Princeton, New Jersey; Redwood Shores, California; and foreign offices in London, United Kingdom; Frankfurt and Munich, Germany; Paris, France; and Beijing, Hong Kong, and Shanghai, China.

2. I submit this supplemental declaration (the “**Declaration**”) to supplement the disclosures contained in my initial declaration, dated July 20, 2020 (the “**Initial Declaration**”), and in my first supplemental declaration, dated August 4, 2020 (the “**First Supplemental Declaration**,” and together with the Initial Declaration, the “**Previous Declarations**”) in support of the *Application of Debtors for Pursuant to 11 U.S.C. § 327(a), Fed. R. Bankr. P. 2014(a) and 2016, and Local Rules 2014 and 2016-1 for Authority to Retain and Employ Weil, Gotshal &*



*Manges LLP as Attorneys for Debtors Effective as of the Petition Date* [Docket No. 28] (the “**Application**”).<sup>1</sup> The Declaration has been prepared in accordance with paragraph 14 of the Initial Declaration, which provides that Weil will supplement the disclosures in the Initial Declaration to the extent required as a result of additional party-in-interest information becoming available during these chapter 11 cases. Unless otherwise stated in the Declaration, I have personal knowledge of the facts set forth herein or related to information provided to me by personnel here at Weil.

3. Subsequent to the filing of the Previous Declarations, the Debtors and their advisors updated the Debtors’ parties-in-interest list to add certain other parties in interest to include (i) Members and Professionals of Unsecured Creditors Committee; (ii) Notice of Appearance Parties/Interested Parties; (iii) Other Significant Contract Counterparties; (iv) Ad Hoc Group of Senior Noteholders, and (v) the United States Trustee. In accordance with the procedures described in the Application and in paragraph 14 of the Initial Declaration, Weil has reviewed the updated parties-in-interest list and conducted additional searches within its records to include these additional parties as well as other parties in interest. These additional parties, along with all other parties for which Weil has conducted searches of its client relationships, are identified on **Schedule 1** attached hereto.

4. As a result, Weil hereby supplements its prior disclosures to disclose that Weil previously has represented, currently represents, and may represent in the future the entities (or their affiliates) set forth on **Schedule 2** hereto (the “**Supplemental Disclosure List**”) in matters unrelated to these Chapter 11 Cases. To the best of my knowledge, information, and belief, neither

Weil nor any of its professional personnel have any relationship with the entities identified on Schedule 2 that would impair Weil's ability to perform services for the Debtors.

5. To the best of my knowledge and information, the annual fees for each of the last two years paid to Weil by any entity listed on the Supplemental Disclosure List or its affiliates did not exceed 1% of the Firm's annual gross revenues.

6. As stated in the Initial Declaration, I believe Weil is "disinterested" as such term is defined in section 101(14) of the Bankruptcy Code, as required by section 327(a) of the Bankruptcy Code, and does not hold or represent an interest adverse to the Debtors' estate. To the extent any information disclosed herein requires amendment or modification upon Weil's completion of further review or as additional party-in-interest information becomes available to it, a further supplemental declaration will be filed stating such amended or modified information.

7. I declare under penalty of perjury that, to the best of my knowledge and after reasonable inquiry, the foregoing is true and correct to the best of my knowledge, information, and belief.
