#### **DEMAND FOR ARBITRATION**

**NOW COMES** ANGELA J. SOTEBEER ("Claimant"), by and through the undersigned counsel, complaining of JOHN C. HEATH, ATTORNEY AT LAW, PC d/b/a LEXINGTON LAW ("Respondent") as follows:

#### NATURE OF THE ACTION

1. Claimant brings this action for damages pursuant to the Credit Repair Organizations Act ("CROA") under 15 U.S.C. §\1679 et seq., Minnesota Statute §332.52 et seq., and Minnesota Uniform Deceptive Trade Practices Act ("MUDTPA") pursuant to Minnesota Statute Section 325D.44 et seq., stemming from Respondent's unlawful conduct.

#### **PARTIES**

- 2. Claimant is a consumer over 18 years of age residing in Minneapolis, Minnesota.
- 3. Respondent is a credit repair organization that claims to "help [consumers] meet [their] credit score goals.<sup>1</sup>" Respondent is a professional corporation that maintains its principal place of business at 2875 Decker Lake Drive, Suite 200, West Valley City, Utah.

4. Respondent acted through its agents, employees, officers, members, directors, heirs, successors, assigns, principals, trustees, sureties, subrogees, representatives and insurers at all times relevant to the instant action.

#### **FACTS SUPPORTING CAUSES OF ACTION**

- 5. Prior to the events giving rise to this action, Claimant began the process of choosing between the purchase of a home or securing rental housing.
- 6. Claimant was unsatisfied with the current standing of her consumer credit reports and began researching companies to help her improve her credit rating and secure more favorable financing or rental options.
  - 7. Claimant subsequently found and reviewed Respondent's services.
- 8. In 2022, Claimant reached out to inquire further about Respondent's services and what Respondent could promise her in return for her business.
- 9. Claimant was explicitly informed that if she made a \$100 payment to Respondent, Respondent would be able to deliver results such as improving her credit rating, and resolving outstanding debts negatively reporting on her consumer reports.
  - 10. Claimant detrimentally relied on Respondent's promise.
- 11. Claimant proceeded to make the \$100 payment to Respondent believing that it would improve her credit rating after receiving her payment.
- 12. Claimant grew disappointed in Respondent's failure to improve her credit rating and failure to remove items from her report, prompting her to express her concerns.
- 13. Sadly, Respondent was unable to alleviate Claimant's concerns and failed to improve Claimant's credit rating despite taking payment from Claimant.

- 14. Throughout their dealings, Respondent deceptively and misleadingly strung Claimant along, telling her what she wanted to hear in order for Claimant to make a payment, only to turn around and fail to deliver on the promises and representations that induced Claimant's participation in Respondent's credit repair services.
- 15. Furthermore, Respondent suggested to Claimant that it would send credit disputes on her behalf as a means to more promptly address the issues on Claimant's credit reports; however, Respondent's conduct in this regard deceptively and misleadingly represented the extent to which the credit reporting agencies are obliged to respond to credit disputes submitted by credit repair organizations.
- 16. Overall, Claimant was promised that her credit rating would increase, but despite paying \$100 for incomplete services, Claimant's credit rating failed to increase.
- 17. Dissatisfied with the money paid for deficient credit repair services, Claimant cancelled her contract with Respondent.
- 18. Frustrated, distressed, and concerned over Respondent's conduct, Claimant spoke with the undersigned regarding her rights.
- 19. Claimant has suffered concrete harm as a result of Respondent's actions, including but not limited to, emotional distress, aggravation, mental anguish, pecuniary loss stemming from the payments made to Respondent for deficient credit repair services, as well as numerous violations of her state and federally protected interests to be free from deceptive and misleading conduct on the part of purported credit repair organizations.

#### COUNT I – VIOLATIONS OF THE CREDIT REPAIR ORGANIZATIONS ACT

20. Claimant repeats and realleges paragraphs 1 through 19 as though fully set forth herein.

- 21. Claimant is a "consumer" as defined by 15 U.S.C. § 1679a(1) of the CROA.
- 22. Respondent is a "credit repair organization" as defined by §1679a(3) of the CROA, as it is a person who uses any instrumentality of interstate commerce or the mails to sell, provide, or perform any service, in return for the payment of money or other valuable consideration, for the express or implied purpose of improving a consumer's credit, credit history, or credit rating, or providing assistance to any consumer with regard to any activity or service for the purpose of improving a consumer's credit.

#### a. Violations of CROA § 1679b(a)

- 23. The CROA, pursuant to 15 U.S.C. § 1679b(a)(3) prohibits any person from "mak[ing] or us[ing] any untrue or misleading representation of the services of the credit repair organization." Additionally, pursuant to 15 U.S.C. § 1679b(a)(4), any person is prohibited from "engag[ing], directly or indirectly, in any act, practice, or course of business that constitutes or results in the commission of, or an attempt to commit, a fraud or deception on any person in connection with the offer or sale of the services of the credit repair organization."
- 24. Respondent violated the above referenced provisions of the CROA through its misrepresentations and deception as to the nature of the credit repair services it could provide Claimant. In order to get Claimant to agree to utilize Respondent's services, Respondent represented that its services would result in an increase in her credit score, and resolve her debts; however, Respondent completely failed to follow through on these promises or the services it represented it would perform for Claimant.
- 25. Further, Respondent violated the CROA when it deceptively represented to Claimant that its disputes would be responded to by the credit reporting agencies. Inherent with Respondent's representations was the notion that there would be an obligation for an investigation

to be triggered by Respondent's submission of a credit dispute on Claimant's behalf. However, pursuant to 12 C.F.R. § 1022.43(b)(2), the credit reporting agencies are under no obligation to respond to disputes submitted by credit repair organizations like Respondent.

**WHEREFORE**, Claimant, ANGELA J. SOTEBEER, respectfully requests that the Arbitrator enter judgment in her favor as follows:

- a. Declaring that the practices complained of herein are unlawful and violate the aforementioned bodies of law;
- b. Awarding Claimant actual damages, as provided under 15 U.S.C. § 1679g(a)(1);
- c. Awarding Claimant punitive damages as provided under 15 U.S.C. § 1679g(a)(2)(A);
- d. Awarding Claimant costs and reasonable attorney fees as provided under 15
   U.S.C. § 1679g(a)(3); and
  - e. Awarding any other relief as the Arbitrator deems just and appropriate.

#### COUNT II - VIOLATIONS OF THE MINNESOTA CREDIT REPAIR ORGANIZATION ACT

- 26. Claimant restates and realleges paragraphs 1 through 25 as though fully set forth herein.
  - 27. Claimant is a "Buyer" as defined by Minnesota Statute 332 §52(2).
- 28. Respondent is a "credit services organization" as defined by Minnesota Statute 332 §52(3).

#### a. Violations of Minnesota Statute § 332.56(4)

29. The Minnesota Statute § 332.56(4), prohibits a credit services organization from "mak[ing] or us[ing] any untrue or misleading representations in the offer or sale of the services

of a credit service services organization or engage, directly or indirectly, in any act, practice, or course of business that operates or would operate as fraud or deception upon any person in connection with the offer or sale of the sale of the services of a credit service organization."

30. Respondent violated § 332.56(4) in much the same way it violated §§ 1679b(a)(3)-(4) of the CROA.

**WHEREFORE**, Claimant, ANGELA J. SOTEBEER, respectfully requests that Arbitrator enter judgment in her favor as follows:

- a. Declaring that the practices complained of herein are unlawful and violate the aforementioned statutes and regulations;
- b. Awarding Claimant actual damages pursuant to Minnesota Statute §
   332.60;
- c. Awarding Claimant punitive damages pursuant to Minnesota Statute §
   332.60;
- d. Enjoin Respondent from further violations of law pursuant to Minnesota Statute § 332.60;
- e. Awarding Claimant's costs and reasonable attorney fees, pursuant to Minnesota Statute § 332.60; and,
  - f. Awarding any other relief the Arbitrator deems just and appropriate.

#### COUNT III – VIOLATIONS OF THE MINN. UNIFORM DECEPTIVE TRADE PRACTICES ACT

- 31. All preceding Paragraphs of this Complaint are expressly adopted and incorporated herein as though fully set forth herein.
- 32. Pursuant to Minnesota Statute Section 325D.44(11), a person engages in a deceptive trade practice when, in the course of business, vocation, or occupation, the person: makes

false or misleading statements of fact concerning the reasons for, existence of, or amounts of price reductions.

- 33. Pursuant to Minnesota Statute Section 325D.44(13), a person engages in a deceptive trade practice when, in the course of business, vocation, or occupation, the person: engages in any other conduct which similarly creates a likelihood of confusion or of misunderstanding.
- 34. Respondent violated Minnesota Statute Section 325D.44(11) and (13) when it represented to Claimant that it could increase her credit score by removing negatively reporting debts from her consumer reports once she made a payment of \$100.
- 35. Moreover, even after Claimant paid the aforementioned \$100, Respondent failed to increase her credit score as promised.
- 36. As outlined above, Respondent violated the above referenced provision of the FCSOA in much the same way it violated 15 U.S.C. §§ 1679b(a)(3)-(4).

**WHEREFORE** Claimant ANGELA J. SOTEBEER, respectfully requests that is Arbitrator for the following relief:

- Declaring that the practices complained of herein are unlawful and violate the aforementioned statutes and regulations;
- Award Claimant reasonable attorney's fees and costs pursuant to Minnesota Statute
   Section 325D.45;
- c. Enjoining Respondent from contacting Claimant pursuant to Minnesota Statute Section 325D.45; and,
- d. Awarding any other relief as the Arbitrator deems just and appropriate.
