**ORDER GRANTING FOURTH MOTION FOR ENTRY OF AN ORDER  
PURSUANT TO 11 U.S.C. § 1121(d) EXTENDING THE EXCLUSIVE PERIODS IN  
WHICH DEBTORS MAY FILE AND SOLICIT ACCEPTANCE OF ONE OR MORE  
CHAPTER 11 PLAN(S)**

THIS CAUSE came before the Court to consider the Debtors’ Fourth Motion for Entry of an Order Pursuant to 11 U.S.C. § 1121(d) Extending the Exclusive Periods in Which Debtors May File and Solicit Acceptance of One or More Chapter 11 Plan(s) filed on December 23, 2022 (the “**Motion**”) [Dkt. No. 220] by the above-captioned debtors and debtors-in-possession (collectively, the “**Debtors**”),<sup>1</sup> in the above-styled jointly administered case (the “**Case**”), and



any timely filed objections thereto. By Notice of Hearing dated December 23, 2022 [Dkt. No. 221], and pursuant to the procedures established under this Court's Second Amended and Restated General Order No. 24-2018, parties in interest were provided with due and proper notice of the Motion, the deadline of January 6, 2023 (the "**Response Deadline**"), to file a response in opposition thereto, and the hearing scheduled for January 11, 2023, to consider the Motion and any timely filed response thereto. No response to the Motion was filed prior to the Response Deadline. Therefore, after considering the Motion and all other matters of record, including the lack of any response in opposition to the Motion, the Court finds that good cause exists to grant the relief sought in the Motion. Therefore, it is hereby,

ORDERED, ADJUDGED AND DECREED as follows:

1. The Motion is granted;
2. Pursuant to 11 U.S.C. § 1121(d)(1), the exclusive period for the Debtors to file one or more chapter 11 plan(s) is hereby extended through and including February 28, 2023, and the exclusive period for the Debtors to obtain acceptances of one or more chapter 11 plan(s) is hereby extended through and including May 1, 2023.
3. Entry of this Order is without prejudice to the Debtors' right to seek a further extension of such exclusive periods.
