



#### DEFINITIONS

**Receivership Estate means:** The Aequitas Entity Defendants and the 43 related entities that comprise the Receivership case, as set forth in the Final Order Appointing the Receiver [Dkt. 156].

**Claimant means:** An individual or entity (including without limitation, partnerships, corporations, joint ventures, estates, trusts, and governmental entities or authorities) asserting or that believes they are entitled to assert a Claim against the Receivership Estate.

**Claim means:** Any (i) potential or claimed right to payment, whether or not such right is based in equity or by statute, reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal equitable, secured, or unsecured; or (ii) a potential or claimed right to an equitable remedy for breach of performance if such breach gives rise to a

right to payment, whether or such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured, or unsecured.

*Aequitas Qualified Settlement Fund Irrevocable Trust* means the fund established pursuant to section 1.468B-1(c), Income Tax Regulations and created upon approval of this Court [Dkt. #781].
