**FIRST SUPPLEMENTAL DECLARATION OF MARK FRANKE IN SUPPORT OF
APPLICATION OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS
FOR AN ORDER AUTHORIZING AND APPROVING THE EMPLOYMENT AND
RETENTION OF ORRICK, HERRINGTON & SUTCLIFFE LLP AS COUNSEL,
EFFECTIVE AS OF AUGUST 19, 2025**

Mark Franke, being duly sworn, states the following under penalty of perjury:

1. I am an attorney at law admitted to practice in the States of New York and Massachusetts. I am an of counsel at the firm of Orrick, Herrington & Sutcliffe LLP (“Orrick”), which maintains offices at 51 West 52nd Street, New York, New York, as well as in other cities across the world. I am familiar with the matters set forth herein and I am authorized to make this declaration on behalf of Orrick.

2. Except as otherwise noted, all facts set forth herein are based on my personal knowledge, information supplied to me by other Orrick professionals or paraprofessionals, or learned from my review of relevant documents. To the extent any information disclosed herein requires amendment or modification as additional party in interest information becomes available, Orrick will submit a supplemental declaration to this Court reflecting such amended or modified information.

3. I submit this declaration (this “Supplemental Declaration”) pursuant to sections 328 and 1103(b) of the Bankruptcy Code, section 1746 of title 28, United States Code, Bankruptcy Rules 2014(a) and 5002, and Local Rule 2014-1 in support of the *Application of the Official Committee of Unsecured Creditors for an Order Authorizing and Approving the Employment and Retention of Orrick, Herrington & Sutcliffe LLP as Counsel, Effective as of August 19, 2025* [Docket No. 192] (the “Application”)² filed on September 15, 2025, and to supplemental my initial declaration that was attached as Exhibit B thereto (the “Original Declaration”).

4. In connection with its proposed employment by the Official Committee of Unsecured Creditors (the “Committee”) in these chapter 11 cases, an attorney working under my supervision reviewed the list of interested persons and entities included on Schedule 1 attached to the Original Declaration (the “Initial Interested Party List”) and searched Orrick’s client database for the last three years and Orrick’s vendor and insurance carrier databases to determine whether Orrick had, within such period of time, any connections to such parties. The Initial Interested Party List consisted of each of the names set forth in the initial list of parties-in-interest provided to Orrick by the Debtors (the “Debtors’ Initial Interested Party List”)³ and, to the extent identified by Orrick, the names of entities and persons identified in other filings made by the Debtors in these chapter 11 cases. Orrick’s conflict search resulted in the disclosures set forth on Schedule 2 attached to the Original Declaration.

5. Orrick agreed to undertake an ongoing analysis to determine whether any material relevant facts or relationships arise or are discovered. *See* Application ¶ 15. In the Original Declaration, I stated that I would supplement the information contained in that declaration if and

when Orrick discovered any further connection or entered into any new relationship with any Potential Parties in Interest. *See* Original Decl. ¶¶ 14, 19.

6. The purpose of this Supplemental Declaration is, among other things, to provide additional information regarding Orrick's representation of two of the Potential Parties in Interest, as follows:

- Orrick currently represents Creative Artists Agency LLC ("Creative Artists") in a single matter commenced in December 2024 to provide regulatory gaming advice to Creative Artists. Orrick's work for Creative Artists is wholly unrelated to the Debtors or these chapter 11 cases.
- Orrick currently represents, and in the past represented, Grant Thornton Advisors LLC ("GT"). Orrick represented GT and certain of affiliates in matters periodically since 1993. Orrick currently provides financial and securities litigation advice to GT on two unrelated matters commenced since July 2022. Orrick's work for GT and its affiliates is wholly unrelated to the Debtors or these chapter 11 cases. With the exception of the two matters that are ongoing, all matters in which Orrick represented GT or its affiliates have concluded.

7. In addition, since the filing of the Original Declaration, Orrick identified additional persons and entities that may be parties in interest in these chapter 11 cases that were omitted from the Debtors' Initial Interested Parties List (the "Additional Potential Parties in Interest"), which are listed on Schedule 1 attached hereto (together with the parties set forth in Schedule 1 to the Original Declaration, the "Potential Parties in Interest").

8. In connection with the preparation of this Supplemental Declaration, Orrick searched its client database for the last three years and Orrick's vendor and insurance carrier databases to determine whether Orrick had, within such period of time, any connections to the Additional Potential Parties in Interest. Based on the results of Orrick's review, to the best of my knowledge, and based upon the information available to me, Schedule 2 attached hereto identifies Additional Potential Parties in Interest who are current clients or vendors or insurance carriers of Orrick or were clients of Orrick within the last three (3) years, as well as any other connection that

Orrick is aware of. To the best of my knowledge, in each instance, any connection of Orrick with the Additional Potential Parties in Interest concerns matters unrelated to the Debtors or these chapter 11 cases.

9. For the avoidance of doubt, to the best of my knowledge, in each instance, any connection of Orrick with the Potential Parties in Interest identified herein or the Original Declaration concerns matters unrelated to the Debtors or these chapter 11 cases.

10. Orrick will file an additional supplemental disclosure with the Court to the extent any material relevant facts or relationships arise or are discovered.
