PLEASE TAKE NOTICE that, on August 4, 2025, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 (the “Bankruptcy Code”), in the United States Bankruptcy Court for the District of Delaware (the “Court”).

PLEASE TAKE FURTHER NOTICE that, on October 15, 2025, the Debtors filed the *Debtors’ Joint Chapter 11 Plan of Liquidation for AGDP Holding Inc. and Its Affiliated Debtors* (as may be amended, modified, or supplemented from time to time, the “Plan”),² and a disclosure statement for the Plan (as may be amended, modified, or supplemented from time to time, the “Disclosure Statement”), pursuant to sections 1125 and 1126(b) of the Bankruptcy Code.

PLEASE TAKE FURTHER NOTICE that, on November 4, 2025, the Court entered an order (the “Solicitation Procedures Order”) approving the Disclosure Statement on an interim basis for solicitation purposes only [D.I. 400]. Subsequent thereto, the Debtors filed solicitation versions of the Plan [D.I. 404] and Disclosure Statement [D.I. 405]. PLEASE TAKE FURTHER NOTICE that, pursuant to the Solicitation Procedures Order, the Combined Confirmation Hearing has been adjourned to **January 20, 2026, at 10:30 a.m., prevailing Eastern Time.**

PLEASE TAKE FURTHER NOTICE that, in connection with the adjournment of the Combined Confirmation Hearing, certain related dates and deadlines, as originally set forth in the Solicitation Procedures Order, have been adjourned or extended as set forth below:
