ORDER SUSTAINING DEBTORS' OBJECTION TO CLAIM NO. 14 FILED BY INLAND RESTORATION DBA SERVPRO OF NORTHWEST AND SOUTH AND EAST SPOKANE

Upon the Objection to Claim No. 14 filed by Inland Restoration dba ServPro of Northwest and South and East Spokane, dated July 3, 2025 [D.I. 522] (the "Objection")² filed by the above-captioned debtors and debtors in possession (collectively, the "Debtors"), for entry of an order

(this "Order") reclassifying the Inland Claim; and the Court having jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334; and the matter being a core proceeding within the meaning of 28 U.S.C. § 157(b)(2); and venue of this proceeding and the Objection in this District being proper pursuant to 28 U.S.C. §§ 1408 and 1409; and due and sufficient notice of the Objection and (i) the opportunity to respond or object to the relief requested in the Objection by August 4, 2025 at 4:00 p.m. (prevailing Eastern Time) (the "Response Deadline") and (ii) the proposed hearing on the Objection, in the event a response or objection is filed by the Response Deadline, scheduled for August 20, 2025 at 1:00 p.m. (prevailing Eastern Time) having been provided in accordance with the Third Amended and Restated General Order No. 24-2018; and no objection or response to the Motion having been filed prior to the Response Deadline; and based on the foregoing, no further notice or hearing is required and the Court finds that good cause exists to grant the relief requested in the Motion; and the Court having considered the Motion and all other matters of record, including the lack of objection thereto,

IT IS HEREBY ORDERED THAT:

- 1. The Objection is SUSTAINED, as set forth herein.
- 2. The Inland Claim is hereby reclassified from a secured claim to a general unsecured claim in the amount of \$40,403.20. The reclassified Inland Claim shall remain on the claims register as a general unsecured claim, subject to the Debtors' or other party-in-interest's further objections on any substantive or non-substantive grounds.
- 3. Nothing set forth in this Order shall be construed as, or shall in any way constitute, a waiver of the Debtors' rights to assert objections to the Inland Claim on any additional grounds whatsoever.

- 4. Debtors' counsel will promptly cause a copy of this Order to be served on the parties listed on the Debtors' Limited Service List for these chapter 11 cases and any parties that were served with the Objection. Debtors' counsel shall cause a Certificate of Service evidencing such service to be filed within three (3) days of service.
- 5. The Debtors and their claims and noticing agent, Verita, as well as the Clerk of the Court, are authorized to take all such actions as are necessary and appropriate to effectuate the terms of this Order.
- 6. This Court shall retain jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
