# DEBTORS' OMNIBUS OBJECTION TO CLAIMS FILED BY AMERICREDIT FINANCIAL SERVICES, INC.

(Disallowance)

The above-captioned debtors and debtors in possession (collectively, the "<u>Debtors</u>") submit this motion (the "<u>Motion</u>") for entry of an order, substantially in the form attached hereto as <u>Exhibit A</u> (the "<u>Proposed Order</u>"), pursuant to sections 105 and 502 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"), Rule 3007 of the Federal Rules of Bankruptcy Procedure (the "<u>Bankruptcy Rules</u>"), and Rule 3007-1 of the Local Rules of the United States Bankruptcy Court for the Northern District of Georgia (the "<u>Local Rules</u>"), (i) disallowing and expunging Claim Nos. 68, 69, 82, 93, 184, 185, 186, and 196 filed by AmeriCredit Financial Services, Inc. dba GM Financial ("<u>AmeriCredit</u>") and (ii) granting related relief. In support of this Objection, the Debtors respectfully state as follows:

#### **JURISDICTION AND VENUE**

- 1. The United States Bankruptcy Court for the Northern District of Georgia (the "Court") has jurisdiction over this matter pursuant to 28 U.S.C. §§ 157 and 1334. This matter is a core proceeding within the meaning of 28 U.S.C. § 157(b)(2).
  - 2. Venue is proper in the Court pursuant to 28 U.S.C. §§ 1408 and 1409.
- 3. The statutory and legal predicates for the relief requested herein are sections 105(a) and 502 of the Bankruptcy Code, Bankruptcy Rule 3007, Local Rule 3007-1, and the *Second Amended and Restated General Order 26-2019, Procedures for Complex Chapter 11 Cases*, dated February 6, 2023 (the "Complex Case Procedures").

#### **BACKGROUND**

#### A. The Chapter 11 Cases

- 4. On March 16, 2025 (the "<u>Petition Date</u>"), each of the Debtors filed a voluntary petition for relief under chapter 11 of the Bankruptcy Code with this Court.
- 5. The Debtors continue to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.
- 6. On March 31, 2025, the United States Trustee for Region 21 (the "<u>U.S. Trustee</u>") appointed an official committee of unsecured creditors (the "<u>Committee</u>") in the above-captioned chapter 11 cases (the "<u>Chapter 11 Cases</u>"). *See Appointment and Notice of Committee of Creditors Holding Unsecured Claims* [Docket No. 111].
  - 7. No request has been made for the appointment of a trustee or an examiner.
- 8. On April 29, 2025, the Court entered the *Order (I) Fixing Deadlines for Filing Proofs of Claim and (II) Approving the Form and Manner of Notice Thereof* [Docket No. 283] (the "Bar Date Order"). The Bar Date Order (a) established June 23, 2025 at 11:59 p.m. (prevailing Eastern Time) (the "General Bar Date") as the last day for creditors that are not

governmental units to file proofs of claim, proofs of interest, and requests for payment of administrative expense claims under Bankruptcy Code section 503(b)(9); (b) established September 12, 2025 at 11:59 p.m. (prevailing Eastern Time) (the "Governmental Bar Date") as the last day for creditors that are governmental units to file proofs of claim, proofs of interest; and (c) approved a form of bar date notice, proof of claim form, and other procedures.

9. Additional information regarding the Debtors' businesses, capital structure, and the circumstances leading to the filing of these Chapter 11 Cases is set forth in the *Declaration of Andrew D.J. Hede in Support of Chapter 11 Petitions and First Day Pleadings* [Docket No. 8].

#### B. The Plan

- 10. On September 4, 2025, the Court entered the Findings of Fact, Conclusions of Law, and Order (I) Approving the Second Amended Disclosure Statement for the Second Amended Chapter 11 Plan of Liquidation of AFH Air Pros, LLC and Its Debtor Affiliates on a Final Basis; and (II) Confirming Second Amended Chapter 11 Plan of Liquidation of AFH Air Pros, LLC and Its Debtor Affiliates [Docket No. 691] (the "Confirmation Order"), which confirmed the Second Amended Plan of Liquidation of AFH Air Pros, LLC and its Debtor Affiliates [Docket No. 479] (as may be further amended, supplemented, or otherwise modified from time to time, and including all exhibits thereto, the "Plan").
- 11. As of the filing of this Objection, the Effective Date under the Plan has not yet occurred.

## C. Claim Nos. 68, 69, 82, and 93 Filed by AmeriCredit

12. Between May 15, 2025 and May 27, 2025, AmeriCredit filed four proofs of claim asserting claims against AFH Air Pros, LLC, and designated 68, 69, 82, and 93 (collectively, the "Original AmeriCredit Claims"). The Original AmeriCredit Claims each assert a secured claim on account of "Money Loaned" by AmeriCredit to a non-Debtor, One Source Home Service LLC

("OSHS"), for automobiles owned by OSHS. The applicable Retail Instalment Sale Contract and Certificate of Title attached to each AmeriCredit Claim reflect OSHS as the Buyer and Owner, respectively. The Original AmeriCredit Claims are summarized as follows:

13. In addition, in July 2025, after the General Bar Date, AmeriCredit filed duplicates of each of the Original AmeriCredit Claims, which were assigned Claim Nos. 184, 185, 186, and 196 (the "<u>Duplicate AmeriCredit Claims</u>", and collectively with the Original AmeriCredit Claims, the "<u>AmeriCredit Claims</u>"). The Duplicate AmeriCredit Claims are duplicates of the Original AmeriCredit Claims as follows:

14. For the reasons set forth below, the AmeriCredit Claims should be disallowed and expunged.

#### **RELIEF REQUESTED**

15. By this Objection, the Debtors request that the Court enter the Proposed Order, pursuant to section 502(b) of the Bankruptcy Code, Bankruptcy Rule 3007, and Local Rule 3007-1, disallowing and expunging the AmeriCredit Claims.

#### BASIS FOR RELIEF REQUESTED

- 16. Bankruptcy Code section 502 provides, in pertinent part, that "[a] claim or interest, proof of which is filed under section 501 of [the Bankruptcy Code], is deemed allowed, unless a party in interest . . . objects." 11 U.S.C. § 502(a). The debtor has a duty to object to the allowance of any claim that is improper. See 11 U.S.C. § 1107(a).
- 17. When asserting a proof of claim against a bankrupt estate, a claimant must allege facts that, if true, would support a finding that the debtor is legally liable to the claimant. *See In re Allegheny Int'l, Inc.*, 954 F.2d 167, 173 (3d Cir. 1992). Where the claimant alleges sufficient facts to support its claim, its claim is afforded prima facie validity. *See id.*; *see also* Bankruptcy Rule 3001(f) (a properly executed and filed proof of claim "constitute[s] prima facie evidence of the validity and amount of the claim").
- 18. A party wishing to dispute a claim's validity must produce evidence sufficient to negate the claim's prima facie validity. *See Allegheny*, 954 F.2d at 173–74. Once an objecting party produces such evidence, the burden shifts back to the claimant to prove the validity of his or her claim by a preponderance of the evidence. *Id.* at 174; *see also Dollinger v. BV Retail, LLC (In re S&Q Shack, LLC)*, 2015 Bankr. LEXIS 1166, at \*6-7 (N.D. Ga. Feb. 13, 2015); *Chambliss v. Oakwood Acceptance Corp. (In re Chambliss)*, 315 B.R. 166, 169 (Bankr. S.D. Ga. 2004). Ultimately, the burden of persuasion is on the claimant. *See In re Moss*, No. 94- 11959, 1995 WL 17005342, at \*1 (Bankr. S.D. Ga. Sept. 28, 1995).
- 19. Bankruptcy Rule 2007(d)(1) permits objections to multiple claims to be joined in a single omnibus objection where the claims were all filed by the same entity. Accordingly, the Debtors object to each of the AmeriCredit Claims in this objection.

#### A. Duplicate AmeriCredit Claims

- 20. Each of the Duplicate AmeriCredit Claims is duplicative of an earlier filed Original AmeriCredit Claim and should be disallowed. More specifically:
  - Claim No. 184 is duplicative of Claim No. 69;
  - Claim No. 185 is duplicative of Claim No. 82;
  - Claim No. 186 is duplicative of Claim No. 68; and
  - Claim No. 196 is duplicative of Claim No. 93.
- 21. Accordingly, the Debtors object to the Duplicate AmeriCredit Claims and request entry of the Proposed Order disallowing and expunging each of the Duplicate AmeriCredit Claims.

#### B. The Original AmeriCredit Claims

- 22. The Debtors and their professionals have reviewed the Original AmeriCredit Claims, including the supporting documentation, and their books and records maintained in the ordinary course of business. Based on that review, the Debtors have determined that each Original AmeriCredit Claim should be disallowed in its entirety.
- 23. Each Original AmeriCredit Claim reflects that OSHS is the (i) contract counterparty to the financing agreement with AmeriCredit and (ii) titleholder of the vehicle securing the claim, as reflected on each applicable Retail Installment Sale Contract and Certificate of Title. OSHS, however, is not a debtor in these Chapter 11 Cases. The Original AmeriCredit Claims do not establish any entitlement to a claim against any of the Debtors. Moreover, the Debtors reviewed their records and inventory and were unable to locate the vehicles purporting to secure the Original AmeriCredit Claims. Thus, the Original AmeriCredit Claims do not establish a claim against the Debtors' estates and should be disallowed and expunged.

#### **RESERVATION OF RIGHTS**

24. The Debtors reserve all rights to amend, modify, or supplement this Objection and the Proposed Order, and to file additional objections to any claims filed in these Chapter 11 Cases. The Debtors further reserve all rights, claims, and defenses with respect to all claims, including the claim addressed herein. Nothing in this Objection or the Proposed Order shall be deemed to impair, waive, or otherwise limit any such rights, claims, or defenses, all of which are expressly preserved.

#### **NOTICE**

25. The Debtors will provide notice of this Motion to the following parties or their respective counsel, if known: (a) the Office of the U.S. Trustee for the Northern District of Georgia, (b) the Committee; (c) the Debtors' prepetition and postpetition lenders and collateral agent; (d) the Limited Service List; (e) AmeriCredit; and (f) any party that has requested notice pursuant to Bankruptcy Rule 2002. The Debtors submit that, in light of the nature of the relief requested, no other or further notice need be given.

- 4. The Debtors and their claims and noticing agent, Kurtzman Carson Consultants, LLC d/b/a Verita, as well as the Clerk of the Court, are authorized to take all such actions as are necessary and appropriate to effectuate the terms of this Order.

5. This Court shall retain jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
