Compensation and Reimbursement of Expenses for the Period from March 16, 2025 Through October 10, 2025 filed October 24, 2025 [Docket No. 791] (the "Application"), seeking allowance of compensation and reimbursement of expenses for services provided as counsel to the Debtors and Debtors in Possession in the above-captioned Chapter 11 Cases. By Notice of Hearing filed on October 24, 2025 [Docket No. 792], and pursuant to the procedures established under this Court's Fifth Amended and Restated General Order No. 24-2018, parties in interest were provided with due and proper notice of the Application, the deadline of November 14, 2025 (the "Response Deadline"), to file a response in opposition thereto, and the hearing scheduled for November 20, 2025 at 2:30 p.m. (prevailing Eastern Time), to consider the Application and any timely filed response thereto. No response to the Application was filed prior to the Response Deadline. Therefore, after considering the Application and all other matters of record, including the lack of any response in opposition to the Application, the Court finds that good cause exists to grant the relief sought in the Application. Therefore, it is hereby

ORDERED, ADJUDGED AND DECREED THAT:

- 1. The Application is approved on a **final** basis, as set forth herein.
- 2. Greenberg Traurig's fees of \$4,380,101.50 and \$9,815.68 as reimbursement of expenses for the period from March 16, 2025 through October 10, 2025, are hereby awarded and allowed on a **final** basis.
- 3. The foregoing award of final compensation and reimbursement of expenses shall be entitled to administrative expense priority under 11 U.S.C. §§ 330(a) and 503(b)(2).
- 4. The Wind Down Debtors are authorized to disburse to Greenberg Traurig any unpaid portion of such allowed fees and expenses.

- 5. Counsel to the Wind Down Debtors will promptly cause a copy of this Order to be served on the parties listed on the Wind Down Debtors' Limited Service List for these Chapter 11 Cases and any parties that were served with the Application. Counsel to the Wind Down Debtors shall cause a Certificate of Service evidencing such service to be filed within three (3) days of service.
- 6. The Wind Down Debtors and their claims and noticing agent, Verita, as well as the Clerk of the Court, are authorized to take all such actions as are necessary and appropriate to effectuate the relief granted in this Order without further order from this Court.
- 7. This Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, and enforcement of this Order
