ADDENDUM TO PROOF OF CLAIM OF BLUE CROSS AND BLUE SHIELD OF NORTH CAROLINA

In response to questions 7 and 8, the Creditor answers as follows:

7. How much is the claim?

Creditor has suffered damages in the form of overcharges for generic pharmaceuticals that it indirectly purchased from Debtor at artificially inflated prices. The full amount of those overcharges and thus the dollar amount of Creditor's claims will not be determined until after discovery and upon proof at trial in the matter, *America's 1st Choice of South Carolina, Inc.*, et al. v. Actavis Elizabeth, LLC, et al., No. 002094, filed in the Pennsylvania Court of Common Pleas of Philadelphia County.

8. What is the basis of the claim?

On July 18, 2019, Creditor commenced suit against Debtor in the Pennsylvania Court of Common Pleas of Philadelphia County by way of Writ of Summons in the matter, *America's Ist Choice of South Carolina, Inc., et al. v. Actavis Elizabeth, LLC, et al.*, No. 002094, for Debtor's alleged participation in an overarching conspiracy with other generic pharmaceutical manufacturers as early as 2010 to the present to avoid competing with each other through market allocation and agreements to set and increase the prices of generic pharmaceutical drugs to extraordinary levels.

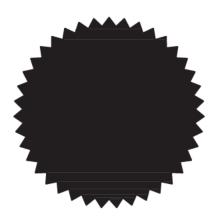
