Re: Response to Objection to Late Filing after the Bar Date

I am writing in response to the objection filed by the AKORN, INC (Debtor) in the Chapter 11 Case No. 20-11177 (KBO) on October 11, 2023, regarding my creditor claim. I appreciate the opportunity to address this matter and provide an explanation for the delay in filing my claim.

I understand the importance of adhering to the bar date and the court's rules and regulations, and I sincerely regret any inconvenience or concern that my late filing may have caused. In my response, I would like to explain the circumstances that led to the late submission of my creditor claim.

I immediately filed the claim for the invested amount of \$2,844.94 and patiently waited for a positive outcome. There was no communication from the Debtor till now.

In light of these circumstances, I respectfully request the court's consideration and leniency in allowing my late-filed claim. I assure the court that I have a valid and substantiated claim against the estate of the AKORN, INC., and it is essential for the equitable distribution of assets in this bankruptcy proceeding.

I understand that the court's primary objective is to ensure fairness and transparency in the bankruptcy process, and I fully support that objective. My intention is not to disrupt the proceedings but to seek a fair resolution of my valid claim.

I kindly request that the court review my explanation and the merits of my claim and grant an exception to the bar date deadline in this case. This will enable me to participate in the distribution of assets, ensuring that creditors are treated fairly and equitably.

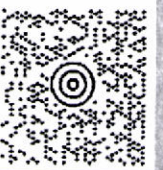
