Upon consideration of the Motion of the Official Committee of Asbestos Personal Injury

Claimants (the “**Committee**”) to file confidential documents under seal (the “**Motion**”)²; and the Committee having demonstrated upon the record herein good cause for the relief requested in the Motion; and after due deliberation

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED.
2. The confidential documents contained within the *Opposition of the Official Committee of Asbestos Personal Injury Claimants to the Debtors’ Motion for Preliminary Injunction or Declaratory Relief* (the “**Opposition to Preliminary Injunction**”) are to remain filed on the public docket in a redacted format.
3. The references in the Opposition to Preliminary Injunction to the confidential documents are to be redacted from the version of the Opposition to Preliminary Injunction filed on the public docket.
4. This Court shall retain jurisdiction with respect to all matters relating to the interpretation or implementation of this Order.
