DEBTORS' UNOPPOSED MOTION TO FILE CONFIDENTIAL DOCUMENTS UNDER SEAL

Plaintiffs Aldrich Pump LLC ("Aldrich") and Murray Boiler LLC ("Murray"), debtors in these chapter 11 cases (collectively, the "Debtors")¹, by and through undersigned counsel, pursuant to 11 U.S.C. § 105(a), 11 U.S.C. § 107(b), Rule 9018 of the Federal Rules of Bankruptcy Procedure, Rule 6.1 of the Rules of Practice and Procedure of the United States District Court for the Western District of North Carolina and Section I(1) of the Agreed Protective Order Governing Confidential Information [Dkt. No. 345] entered on September 23, 2020 ("Protective Order"), hereby file this Motion for an Order Authorizing the Filing of Certain Confidential Documents Under Seal and/or in a redacted format (the "Motion") related to the



Official Committee of Asbestos Personal Injury Claimants' (the "Committee's") Deposition Designations (the "Committee Designations").

Background

1. Debtors seek an order permitting limited portions of deposition transcripts of several witnesses to be filed under seal. The portions of deposition testimony that the Debtors seek to have sealed were included in the Committee Designations and were also previously designated by the Debtors as "Confidential" pursuant to the Protective Order.

2. On September 23, 2020, this Court entered the Protective Order that had been previously executed by the Debtors, the Non-Debtor Affiliates², and the Committee. Dkt. No. 345. The Future Claimants' Representative ("FCR") elected to become a party to the Protective Order on October 15, 2020. See Notice of Election of Future Claimants Representative to Become a Party to Modified Protective Order (Dkt. No. 395).

3. The Protective Order governs the rights and obligations of the parties to it with respect to "Confidential Information," which is defined as:

[I]nformation, documents, or things produced or provided (formally or informally) by the Disclosing Party that such Disclosing Party or a Designating Party reasonably believes in good faith contains confidential, proprietary or commercially sensitive information including, but not limited to (a) trade secrets, (b) proprietary business information, and (c) information implicating an individual's legitimate expectation of privacy, including medical information and social security numbers. This term shall include information furnished or otherwise disclosed in any manner, including, without limitation, in written form, orally or through any electronic, facsimile or computer-related communication, and also shall include, without limitation, (i) those portions of deposition testimony

(whether based upon oral examination or written questions), answers to interrogatories, requests for admissions, responses to requests for admission, notes, summaries, compilations, memoranda, or similar materials disclosing or discussing Confidential Information and (ii) any Oral Confidential Information.

Protective Order at 3-4.

4. In the case of depositions, Section C.2 of the Protective Order provides that:

In the case of depositions, if counsel for the Designating Party believes that a portion or all of the testimony given at a deposition constitutes Confidential Information, counsel may so state on the record and request that the entire transcript or relevant portion thereof be sealed. In addition, the Designating Party may also designate the relevant portion of the transcript or videotape of a deposition, and any exhibits thereto, as Confidential Information within 30 days of the Designating Party's receipt of the transcript from the court reporter. Such designation and notice shall be made in writing to the court reporter, with copies to all other counsel of record at the deposition and any Disclosing Party or Designating Party, in the case where the Disclosing Party and Designating Party were not in attendance at the deposition, identifying the portion of the transcript, or exhibits thereto, that constitute items designated as Confidential Information. All pages of the transcript and exhibits designated as Confidential Information shall be stamped "CONFIDENTIAL."

Protective Order at 7.

5. The testimony the Debtors request be sealed are excerpts from the following deposition transcripts, which are included amongst the Committee's Designations, and which the Debtors have designated as Confidential under Section C.2 of the Protective Order (the "Confidential Deposition Excerpts"):

- Transcript of the Deposition of Manlio Valdes, March 1, 2021, containing confidential and commercially sensitive information at 74:9-12, 75:9-11, and 165:5-7;

Argument

6. This Court has jurisdiction over this Motion pursuant to 28 U.S.C. §§ 157 and 1334, and this matter is a core proceeding within the meaning of 28 U.S.C. § 157(b).

7. The statutory bases for the relief requested herein are 11 U.S.C. § 105(a), 11 U.S.C. § 107(b) and the Federal Rule of Bankruptcy Procedure 9018. 11 U.S.C. § 105(a) gives this Court authority to "issue any order, process, or judgment that is necessary or appropriate to carry out the provisions of this title." The Bankruptcy Code authorizes the Court, in appropriate circumstances, to issue orders to protect entities from potential harm that may result from the disclosure of Confidential Information. 11 U.S.C. § 107(b). Federal Rule of Bankruptcy

Procedure 9018 provides that "[o]n motion or on its own initiative, with or without notice, the court may make any order which justice requires (1) to protect the estate or any entity in respect of . . . confidential . . . commercial information."

8. The testimony that Debtors seek to seal involve confidential and commercially sensitive business information pertaining to, among other things, non-public transactions pertaining to the Debtors' operating subsidiaries, non-public projections of the Debtors' future asbestos liabilities and insurance recoveries, and confidential settlement amounts. The disclosure of this information could potentially cause competitive or economic harm to the Debtors. Ex. A, Allan Tananbaum Declaration in Support of Debtors' Motion to File Confidential Documents Under Seal, ¶ 3.

9. The Debtors have consulted with the Committee, the FCR and the Non-Debtor Affiliates, and those parties have no objection to the relief sought by the instant Motion to Seal.

10. As provided for in the Protective Order, the Debtors will deliver an unredacted copy of the copy of the Confidential Information to this Court.

Wherefore, the Debtors respectively request that the Court enter an order, Attached hereto as Ex. B, granting the Debtors' Motion to Seal.

**DECLARATION OF ALLAN TANANBAUM IN SUPPORT OF DEBTORS'
UNOPOSED MOTION TO FILE CONFIDENTIAL DOCUMENTS UNDER SEAL**

I, Allan Tananbaum, being first duly sworn, deposes and states as follows:

1. I am the Chief Legal Officer of Aldrich Pump LLC, a North Carolina limited liability company ("Aldrich") and Murray Boiler LLC, a North Carolina limited liability company ("Murray"). Aldrich and Murray are the debtors and debtors in possession in the above-captioned chapter 11 cases (together, the "Debtors") and the plaintiffs in the above-captioned adversary proceeding. I have been the Chief Legal Officer for each of the Debtors since their formation on May 1, 2020.

2. The facts, statements, and opinions set forth in this Declaration are based on my personal knowledge and my business experience.

3. The public disclosure of the testimony listed in Paragraph 5 below would cause serious competitive injury to Debtors because the testimony contains business information that is maintained as highly confidential by Debtors and whose public disclosure would cause serious business injury to Debtors by aiding Debtors' competitors and by adversely affecting Debtors' operations and employees:

- a. The Confidential portions of Mr. Valdes's deposition transcript include testimony concerning the dollar values certain commercially sensitive business and non-public transactions pertaining to the Debtors operating subsidiaries. Valdes Dep. at 74:9-12, 75:9-11, and 165: 5-7.
- b. The Confidential portions of Ms. Roeder's deposition transcript include testimony concerning the dollar values for certain non-public transactions pertaining to the Debtors operating subsidiaries and other companies in the Debtors' corporate family, and non-public dollar value estimates for asbestos liability pertaining to the Debtors. Roeder Dep. at 84:3, 91:12-13, 92:8-18, 93:3-95:16, 110:25-111:5, 111:12-19, 112:2-3, 171:12, 172:5-14, 176:6, 187:5-11, 188:11-14, 196: 14-17 196:24-197:13, 198:4-20, 200: 2-5, 200: 17-19, 202: 21-22, 203: 25-204:3, 205: 6-9, 206: 15-19, 215: 8-10, 223:24-224:3.
- c. The Confidential portions of Mr. Pittard's deposition transcript include testimony concerning commercially sensitive business and non-public transactions pertaining to the Debtors' operating subsidiaries, as well as non-public liability projections pertaining to the Debtors. Pittard Dep. at 90:5-25, 91:1-7, 172:23-25, 173: 2-11, 329: 14-24, 331: 3-8.

- d. The Confidential portions of my individual deposition transcript include testimony concerning commercially sensitive and non-public information regarding Debtors' consultants, Debtors' settlement amounts, and the dollar valuations of Debtors' operating subsidiaries. The Confidential portions also include discussions of exhibits designated as Confidential under the Protective Order and which remain under seal. Tananbaum Dep. at 100:3-7, 196:12-25, 216:17-25, 217:2-19, 236:10-23, 237:2-3, 301:9-25, 302:2-13, 338:16-339:25.
- e. The Confidential portions of my 30(b)(6) deposition transcript include testimony concerning commercially sensitive and non-public information regarding employee compensation, insurance purchase options, and insurance valuations. Tananbaum 30(b)(6) Dep. at 248:14-249:13, 249:15-17, 250:4-10, 264:12, 266:10-11, 14, 320:12-324:2, 324:13-16, 331:14-332:2, 333:22-23, 349:10-15, 387:21-23, 389:8-9, 12, 16-18.

I declare under penalty of perjury that the foregoing is true and correct to the best of my information, knowledge, and belief.
