**STIPULATION REGARDING AMENDMENT OF CERTAIN  
PROOFS OF CLAIM FILED BY SIMMONS HANLY CONROY, LLC**

Aldrich Pump LLC ("Aldrich") and Murray Boiler LLC ("Murray"), as debtors and debtors in possession (together, the "Debtors") jointly administered in the above-captioned case, and Simmons Hanly Conroy, LLC ("Simmons"), as counsel for certain asbestos claimants (the "Claimants"), hereby stipulate (the "Stipulation") as follows:

WHEREAS, on June 18, 2020, the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code, and by an order entered on June 25, 2020, the Debtors' cases have been consolidated for procedural purposes only and are being jointly administered under Case No. 30608 [Dkt. 114].

WHEREAS, on April 4, 2022, the Court entered an order ("Bar Date Order") establishing the last date and time for filing certain proofs of claim against the Debtors as July 29, 2022 [Dkt. 1093] (the "Bar Date"). The proof of claim form approved by the Court requires creditors to designate the specific Debtor against which the creditor asserts its claim.

WHEREAS, Simmons, on behalf of the Claimants, filed 310 Proofs of Claim (the "Simmons Proofs of Claim"), which are detailed on Exhibit 1 and Exhibit 2 attached hereto, against both Debtors, asserting various asbestos personal injury related claims.

WHEREAS, upon review of the Debtors' books and records, counsel to the Debtors initiated discussions with counsel to the Claimants regarding, among other things, whether the Simmons Proofs of Claim were properly asserted against both Debtors.

WHEREAS, Simmons has determined that the Claimants listed on the attached Exhibit 1 do not have a prepetition mesothelioma claim, as defined by the Bar Date Order, against Murray and, therefore, those Simmons Proofs of Claim should be withdrawn as to Murray, and remain solely asserted as to Aldrich.

WHEREAS, Simmons has determined that the Claimants listed on the attached Exhibit 2 do not have a prepetition mesothelioma claim as defined by the Bar Date Order against Aldrich and, therefore, those Simmons Proofs of Claim should be withdrawn as to Aldrich, and remain solely asserted as to Murray.

NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED, by and between the Debtors and counsel to the Claimants, as follows:

1. The Simmons Proofs of Claim, which are detailed in Exhibit 1 attached hereto, shall be withdrawn as to Murray, and amended to reflect that those Simmons Proofs of Claim are asserted solely against Aldrich.



2. The Simmons Proofs of Claim, which are detailed in Exhibit 2 attached hereto, shall be withdrawn as to Aldrich, and amended to reflect that those Simmons Proofs of Claim are asserted solely against Murray.

3. Notwithstanding anything to the contrary set forth in the Bar Date Order, the Bankruptcy Code, the Federal Rules of Bankruptcy Procedure, or the Rules of Practice and Procedure of the United States Bankruptcy Court for the Western District of North Carolina, this Stipulation shall constitute the amendment of each Simmons Proof of Claim to reflect the proper Debtor against which each such Simmons Proof of Claim is asserted in the Debtors' bankruptcy cases.

4. This Stipulation is intended solely for the purposes of administrative convenience to amend each Simmons Proof of Claim solely with respect to the Debtor against which it is asserted and not as to the merits of each such Simmons Proof of Claim. Nothing in this Stipulation shall affect the substantive rights of the Debtors, the Claimants, Simmons, or any other party in interest with respect to the Simmons Proofs of Claim.
