**NOTICE OF EMERGENCY VIRTUAL HEARING ON FIRST DAY MOTIONS**

**PLEASE TAKE NOTICE** that on December 16, 2025, Ample, Inc. and its debtor affiliate in the above-captioned cases, as debtors and debtors in possession (collectively, the “Debtors”) filed voluntary petitions for relief under title 11 of the United States Code in the United States Bankruptcy Court for the Southern District of Texas, Houston Division (the “Court”) commencing these chapter 11 cases.

**PLEASE TAKE FURTHER NOTICE** that in accordance with the Procedures for Complex Cases in the Southern District of Texas, an emergency, virtual hearing is set for December 18, 2025 at 2:00 p.m. (prevailing Central Time) (the “First Day Hearing”), before the Honorable Christopher M. Lopez to consider the matters (collectively, the “First Day Motions”) set forth below.

**PLEASE TAKE FURTHER NOTICE** that the First Day Hearing will be conducted virtually only. No in-person attendance will be permitted. Audio communication will be by use of the Court’s dial-in-facility. The dial-in number is (832) 917-1510. Once connected, you will be asked to enter the conference room number. Judge Lopez’s conference room number is 590153. Video communication will be by the use of the GoToMeeting platform ([www.gotomeeting.com](http://www.gotomeeting.com)). Connect via the free GoToMeeting application or click the link on Judge Lopez’s home page.<sup>2</sup> The meeting code is “JudgeLopez”. Click the settings icon in the upper right corner and enter your name under the personal information setting.

**PLEASE TAKE FURTHER NOTICE** that hearing appearances must be made electronically in advance of the hearing. To make your electronic appearance, click the “Electronic Appearance” link on Judge Lopez’s home page. Select the case name, complete the required fields and click “Submit” to complete your appearance.
