Steven D Sass LLC, as GUC Distribution Trustee¹ (the "GUC Distribution Trustee"), by and through its undersigned counsel, hereby objects (the "Objection"), pursuant to section 502 of title 11 of the United States Code (the "Bankruptcy Code"), Rules 3007 and 9014 of the Federal Rules of Bankruptcy Procedure (the "Bankruptcy Rules"), Rule 3007-1 of the Local Rules of Bankruptcy Procedure for the Eastern District of Washington (the "Local Rules"), and the Order Granting Motion of the GUC Distribution Trustee for an Order Authorizing the Filing of Omnibus Objections with Respect to Categories of Claims Consisting of Two or More Claims [Docket No. 2785] (the "Objection Authorization Order"), to the (i) the satisfied claims identified on **Exhibit A** hereto (the "Satisfied Claims"), and (ii) the insured claims identified on Exhibit B hereto (the "Insured Claims," and collectively with the Satisfied Claims, the "Claims"), and seeks entry of an order, substantially in the form attached hereto as **Exhibit C** (the "Proposed Order"), disallowing and/or expunging the Claims, as applicable. In support of the Objection, the GUC Distribution Trustee respectfully states as follows:

JURISDICTION AND VENUE

- 1. The Court has jurisdiction over the Objection pursuant to 28 U.S.C. §§ 157 and 1334. The Objection is a core proceeding under 28 U.S.C. § 157(b)(2).
 - 2. Venue is proper in the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

3. The basis for the relief requested herein is section 502 of the Bankruptcy Code, Bankruptcy Rules 3007 and 9014, Local Rule 3007-1, the Objection Authorization Order, and such additional authorities as are cited below.

BACKGROUND

- 4. On May 6, 2019 (the "Petition Date"), the Debtors commenced voluntary cases under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the Eastern District of Washington.
- 5. On December 23, 2020, the Court entered the *Order Confirming* Modified Second Amended Joint Chapter 11 Plan of Reorganization of Astria Health and Its Debtor Affiliates [Docket No. 2217] (the "Confirmation Order"), which among other things, confirmed the Plan.
- 6. The Effective Date of the Plan occurred on January 15, 2021 [Docket No. 2264].
- Pursuant to the Plan, Steven D Sass LLC was appointed as the GUC 7. Distribution Trustee (Plan $\S III(F)(1)$; Confirmation Order $\P 9(e)$), and the GUC Distribution Trustee was granted the authority, subject to certain procedural requirements set forth in the Plan, to File objections to and settle disputes regarding General Unsecured Claims (Plan §§ III(F)(2) and (M)).
- 8. Since the Effective Date of the Plan, the GUC Distribution Trustee, through its staff and professionals, has undertaken a comprehensive review and reconciliation of General Unsecured Claims filed or otherwise asserted against the Debtors or their consolidated Estate (see Plan § II(B) (providing that, except as

otherwise set forth in the Plan or ordered by the Court, "all assets and all liabilities of each of the Debtors shall be deemed merged or treated as though they were merged into and with the assets and labilities of each other," and "each and every Claim filed or to be filed in any of the Chapter 11 Cases shall be treated as if filed against the consolidated Debtors and shall be treated [as] one Claim against and obligation of the consolidated Debtors")).

- In furtherance of the GUC Distribution Trustee's review and 9. reconciliation of General Unsecured Claims, the GUC Distribution Trustee has, among other things, undertaken a review and comparison of the scheduled and/or asserted General Unsecured Claims, their supporting materials, and the books and records maintained by the Debtors in the ordinary course of business (as such Books and Records have been provided by the Reorganized Debtors, the "Books and Records") to determine the validity of the scheduled and/or asserted General Unsecured Claims.
- 10. The GUC Distribution Trustee's General Unsecured Claims reconciliation process has also included the identification of particular categories of General Unsecured Claims that may be subject to, inter alia, disallowance, reduction, reassignment, and/or reclassification. To reduce the number of General Unsecured Claims and avoid improper recoveries by parties asserting General Unsecured Claims that should be disallowed, reduced, reassigned, and/or reclassified, the GUC Distribution Trustee anticipates filing multiple claim objections.

RELIEF REQUESTED

- 11. By this Objection, pursuant to section 502 of the Bankruptcy Code, Bankruptcy Rules 3007 and 9014, Local Rule 3007-1, and the Objection Authority Order, the GUC Distribution Trustee objects to (i) the Satisfied Claims identified in **Exhibit A** hereto, and (ii) the Insured Claims identified in **Exhibit B** hereto, and seeks entry of on order, substantially in the form of the Proposed Order attached hereto as **Exhibit C**, disallowing and/or expunging, as applicable, such Claims as set forth herein and in **Exhibits A - B**.
- 12. Although a properly filed proof of claim constitutes prima facie evidence of the validity and amount of the claim, once evidence to rebut a claim's prima facie validity has been presented, "the creditor must present evidence to prove the claim. The ultimate burden of proof therefore is on the creditor." Franchise Tax Bd. v. MacFarlane (In re MacFarlane), 83 F.3d 1041, 1044 (9th Cir. 1996). For the reasons set forth below and in **Exhibits A - B**, any purported *prima facie* validity of the Claims is rebuttable, and the applicable claimants cannot meet their burdens of proof with respect to their respective Claims. The Claims should therefore be disallowed and /or expunged, as applicable.

The Satisfied Claims

13. Consistent with his duties and authorities under the Plan, since the Effective Date, the GUC Distribution Trustee has pursued avoidance and recovery of numerous preferential transfers. The GUC Distribution Trustee made demands for return of asserted avoidable transfers and/or commenced adversary proceedings

against dozens of persons and entities, including those who had filed proofs of asserted general unsecured claims against the Debtors' estates.

To date, the GUC Distribution Trustee has reached settlements of 14. preference actions with thirty-eight (38) parties who have waived and released their claims against the Debtors' estates as part of and in consideration of their settlement agreements with the GUC Distribution Trustee. Based upon a review of the claims identified in such settlements, filed proofs of claim and the claims register, the docket, and the Books and Records, the GUC Distribution Trustee has determined that the Claims identified in **Exhibit A** have been fully satisfied as a result of the waivers and releases exchanged pursuant to settlement agreements of avoidance actions between the GUC Distribution Trustee and the applicable claimants set forth in **Exhibit A**. The Satisfied Claims should therefore be disallowed and expunged in their entirety as set forth in **Exhibit A**.

The Insured Claims

15. Section 1.101 of the Plan defines Insured Claims as "General Unsecured Claims arising prior to the Confirmation Date involving personal injury, medical malpractice, or wrongful death (including slip-and-fall and medical malpractice Claims) that are covered by the terms of Debtors' various insurance policies (including the Insurance Policies), or any other General Unsecured Claim against a Debtor for which the Debtor is entitled to indemnification, reimbursement, contribution or other payment under a policy of insurance (including the Insurance Policies) under which the Debtor is an insured or beneficiary of the coverage

provided under the applicable policy."

- Insured Claims comprise Class 4A of the Plan. Section II(E)(4) of the 16. Plan provides in relevant part that "Holders of Allowed Insured Claims in Class 4A" shall recover only from the available insurance and Debtors shall be discharged to the extent of any such excess."
- Based upon a review of the proofs of claim identified in **Exhibit B**, the 17. GUC Distribution Trustee has determined that such claims are Insured Claims as defined under the Plan because such claims are alleged General Unsecured Claims arising prior to the Confirmation Date involving alleged personal injury or medical malpractice that are covered by the terms of the Debtors' various applicable insurance policies.
- 18. The Insured Claims should therefore be expunged in their entirety consistent with their treatment under the Plan as such claims are not entitled to any recovery from the GUC Distribution Trust.

Response is directed; (ii) the name of the claimant and his/her/their/its Claim number (scheduled or filed); (iii) the specific factual basis and supporting legal argument upon which the claimant will rely in opposing this Objection; (iv) any supporting documentation, to the extent it is not included in the proof of claim previously filed with the Court or claims agent, upon which the party will rely in order to support the basis for and amounts asserted in the applicable Claims; and (v) the name, address, telephone number, and email of the person(s) (which must be the claimant or the claimant's legal representative) with whom counsel for the GUC Distribution Trustee should communicate with respect to the applicable Claim and the Objection, and who possesses authority to reconcile, settle, or otherwise resolve the objection to the disputed Claim on behalf of the claimant.
