Moorestown National DC-Decision was made to decommission after the operation was transferred to Smyrna. Bill DeShields did the decommissioning as a line item of the Upper Marlborough project. Shelving and racking materials were shipped to Upper Marlborough. Billing for this will be final when the Upper Marlborough billing is finalized.

Denver- Decision made to announce closure in October of 2012. Operations ceased in December 2012. Inventory transfers went through end of January 2013. Teardown was done by Bill DeShields; 100% billed. Materials were stored on site as we had time remaining on the lease, until ready to be shipped to Upper Marlborough for use there. This shipment also enabled us to execute an early out and gain a rent reduction from the Landlord.

Oklahoma City-Decision made to announce closure in June of 2013. Operations ceased in July. Inventory transfers took until October to be finalized. Challenges were caused by the closure of 50 stores during this same time period. Warehouses were unable to digest all the incoming. Some inventory was actually held and shipped to Washington when they were ready to receive inventory. DeShields disassembled the warehouse. Shelving went to New Roanoke HUB store, Upper Marlborough, J.K our store group in Washington and some to Avon. Billing is 90% finalized.

San Antonio-Decision was made to announce closure in July of 2013. Operations ceased in August. Inventory transfers continued for several months. DeShields disassembled the warehouse. Materials were stored on site until parceled out to Dallas, a company store build in Aberdeen, a customer in Hagerstown, Finishmaster and final remnants were sold to a local shelving broker. The material was primarily of a manufacturer that was out of business. Most of billing has been done but it needs to be finalized.

Tallahassee- Decision was made to announce closure in September 2013; operations ceased September 13. Inventory transfers took only a month as this was a small warehouse. Teardown was handled locally.

Toms River- Decision was made to announce closure in September of 2013; operations ceased September 28, 2013. Inventory transfers took less than a month as this was a small warehouse. Teardown was handled locally.

Roanoke- Decision was made in 2012 as part of the Washington project that Roanoke would close. Operations ceased December 1, 2013, when the last customers were re-directed to either, Upper Marlborough, Austell or Charlotte. Their inventory was transferred either to Upper Marlborough, or to suppliers via direct returns. DeShields did the disassembly. Materials were stored on site until the final weeks of our lease which ended in May of 2014. 25 full T/L of shelving and racking was shipped to Avon in the last two weeks of May, with special permission from our future landlord as we did not yet have the right to occupy new location until June 1, 2014, but we had to vacate the Roanoke building by month end. Billing has not been finalized; there may be a small additional billing.

Hyattsville- Decision was made in 2012 as part of the Washington project that Hyattsville would close. Operations ceased November 1, 2013, when the customers were re-directed to Upper Marlborough. Inventory was transferred internally and also via factory returns. DeShields did the disassembly. Materials were stored on site until they could be shipped to Avon and Turtle Creek. Billing complete.

Binghamton- Decision was made to down size the location from 85,000 sq-ft to approximately 25,000 sq-ft and write off the prorate portion of the future lease obligation. Size reduction was handled internally. Materials were redeployed on site and excess was shipped to Project North (5 locations)

Randolph- De-commissioning was done by Bill DeShields. Materials were shipped to Project North (5 locations), Green Island store, Turtle Creek and storage in Ohio. Billing is not finalized.

Milford- Decision was made to down size the location from 60,000 sq-ft to approximately 15,000 sq-ft and write off the prorate portion of the future lease obligation. De-commissioning was done by Bill DeShields. Materials were redeployed on site and excess was shipped to Project North (5 locations). Materials were shipped to Project North (5 locations), Turtle Creek and storage in Ohio. Billing is not finalized.

~~Fonawanda- De-commissioning was done by Bill DeShields. Materials were shipped to Project North (5 locations), Turtle Creek and storage in Ohio. Billing needs to be finalized for final cleanout and a few freight bills.~~
