**FINAL ORDER ALLOWING
COMPENSATION AND REIMBURSEMENT OF EXPENSES**

The Court has considered the *First and Final Fee Application of KPMG LLP Providing Tax Compliance, Tax Provision, Tax Restructuring, Tax Consulting, and Related Services to the Debtors Requesting Entry of an Order (I) Granting Allowance of Compensation for Services Rendered and Reimbursement of Expenses Incurred for the Period from February 14, 2023, Through March 22, 2023, and (II) Authorizing and Directing the Reorganized Debtors to Pay Any and All Unpaid Fees (the “Application”)*² filed by KPMG LLP (the “Applicant”). The Court orders:

1. Applicant is allowed compensation and reimbursement of expenses in the amount of \$1,287,979.51 for the period set forth in the Application.
2. The compensation and reimbursement of expenses allowed in this Order are approved on a final basis.
3. The Reorganized Debtors are authorized to disburse any unpaid amounts allowed by paragraphs 1 or 2 of this Order.
