Each Late-Filed Claim identified in <u>Schedule 5</u> attached hereto, each No Liability Claim identified in <u>Schedule 6</u> attached hereto, each Insufficient Documentation Claim identified in <u>Schedule 7</u> attached hereto, each Superseded Claim identified in <u>Schedule 8</u> attached hereto, and each Cross-Debtor Duplicate Claim identified in <u>Schedule 9</u> attached hereto, and each Duplicate Claim identified in <u>Schedule 10</u> attached hereto- is disallowed in its entirety. 5. Each Multiple Modifications Claim identified in <u>Schedule 8</u> attached hereto is reduced and reclassified to the extent and in the manner set forth in <u>Schedule 8</u>.

3. 6. The Debtors and their claims agent are authorized to take all actions necessary to effectuate the relief granted in this Order, including updating the Claims Register to reflect the relief granted herein.

With respect to any Foreign Litigation Claim reinstated pursuant to clause (i) of this paragraph 3, the Reorganized Debtors shall have 60 days from the date of filing of the applicable Discontinuation Affirmation to file an objection to the Foreign Litigation Claim that is the subject of such Discontinuation Affirmation, notwithstanding any other orders of this Court or other relief granted in these chapter 11 cases.
