NOTICE OF WITHDRAWAL OF CLAIM OBJECTIONS

PLEASE TAKE NOTICE that on December 2, 2022, the above-captioned reorganized debtors and their reorganized debtor affiliates (the “Reorganized Debtors”) filed the *Objection of Aerovías del Continente Americano S.A. Avianca, Avianca, Inc., and Tampa Cargo S.A.S. to Claim Numbers 2215, 2222, 2223, 2224, and 4097 Filed by Rolls-Royce PLC and Rolls-Royce Leasing Ltd.* [Docket No. 2664] (the “Rolls-Royce Claim Objection”).

PLEASE TAKE FURTHER NOTICE that on December 2, 2022, the Reorganized Debtors filed the *Objection of Avianca Holdings S.A. to Certain Claims Filed by the Travel Agencies* [Docket No. 2665] (the “Travel Agencies Claim Objection”).

PLEASE TAKE FURTHER NOTICE that, in light of such resolutions, the Reorganized Debtors hereby withdraw the Rolls-Royce Claim Objection, except with respect to claim numbered 2222, and the Travel Agencies Claim Objection, both without prejudice.
