ADDENDUM TO PROOF OF CLAIM

1. On May 10th, 2020 (the "Petition Date"), Taca International Airlines S.A. ("Debtor"), filed voluntary petitions for relief under Chapter 11 of Title 11 of the United States Code (the "Bankruptcy Code") in the United States Bankruptcy Court for the Southern District of New York.

2. This proof of claim is filed by Accenture Ltda. ("Accenture" or "Claimant") and is evidenced and supported by the following (collectively, the "Contract Documents"):

- a. That certain 20191112-02OS Service Order dated as of January 31st, 2020 (the "Contract") under the Master Service Agreement N^o 10705285, dated as of April 10th, 2010 (the "MSA"), by and between Accenture and the Debtor.¹
- b. All other agreements and documents, including change orders and contract work authorizations, executed and delivered in connection therewith, as amended, supplemented or revised from time to time.
- c. All other documents including invoices, purchase orders and confirmation emails.

3. This Claim relates to a Project referred to as "New Booking Flow Implementation Support" and is not intended to cover all work performed by Accenture in connection with Contract Documents. Accenture expressly reserves its rights to amend this Claim or file an additional Claim with respect to other work performed in connection with the Contract Documents.

4. As of the Petition Date, the outstanding and unpaid balance owed by the Debtor to Accenture under the Contract Documents was in the amount of USD 14,790.17, as set forth in Contract, Invoice or another document containing the services.

5. Creditor expressly reserves its rights to otherwise amend, modify or supplement this Proof of Claim.

¹ The Contract contains confidentiality provisions that could be interpreted to include the terms of the contract and/or change orders, and, thus, the Contract and any change orders are not being filed with this Proof of Claim. The Debtor is in possession of the documents referenced herein, and Claimant will provide a copy of the documents to the Court should the Court wish to examine them, and, if necessary and appropriate, will do so under seal.

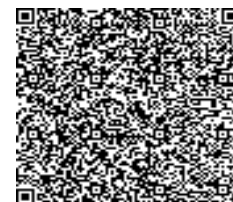

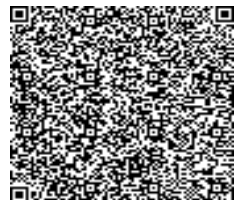
