- 4. Subsequent to the filing of the Initial Declaration, the Debtors and their advisors updated the Debtors' parties in interest list to add certain other parties in interest to include (i) Debtor Counsel for Non-Restructuring Matters; (ii) Ordinary Course Professional Service Providers; (iii) Other Significant Contract Counterparties; (iv) Professional Service Providers to the Stalking Horse Bidder; (v) Stalking Horse Bidder; (vi) Additional ABL Party and (vii) Additional Utility Service Providers.
