**NOTICE OF THE PLAN ADMINISTRATOR’S THIRTY-SECOND
OMNIBUS OBJECTION TO CLAIMS (SATISFIED SCHEDULED CLAIMS)**

THIS IS AN OBJECTION TO YOUR SCHEDULED CLAIM. THE OBJECTING PARTY IS ASKING THE COURT TO ACKNOWLEDGE THAT THE CLAIM THAT THE DEBTORS SCHEDULED FOR YOU IN THESE BANKRUPTCY CASES HAS BEEN SATISFIED, IN WHOLE OR IN PART.

LOUIS, MISSOURI 63102, AND A COPY SERVED UPON COUNSEL TO THE PLAN ADMINISTRATOR, (A) HALPERIN BATTAGLIA BENZIJA LLP, 40 WALL STREET, 37TH FLOOR, NEW YORK, NEW YORK 10005 (ATTN: JULIE DYAS GOLDBERG, ESQ. AND CARRIE E. ESSENFELD, ESQ.) AND (B) CARMODY MACDONALD P.C., 120 S. CENTRAL AVENUE, SUITE 1800, ST. LOUIS, MISSOURI 63105 (ATTN: DORMIE KO, ESQ.), SO THAT THE RESPONSE IS RECEIVED NO LATER THAN 11:59 P.M. (PREVAILING CENTRAL TIME) ON JANUARY 6, 2022.

FAILURE TO FILE A TIMELY RESPONSE MAY RESULT IN THE COURT GRANTING THE RELIEF REQUESTED PRIOR TO THE HEARING DATE. YOU SHOULD READ THIS NOTICE AND THE ACCOMPANYING CLAIM OBJECTION CAREFULLY AND DISCUSS THEM WITH YOUR ATTORNEY, IF YOU HAVE ONE.

Important Information Regarding the Objection

1. Grounds for the Objection. By this Objection,¹ the Plan Administrator, on behalf of the Wind-Down Estates of the Debtors, is seeking to deem the scheduled claims identified on **Exhibit A** and **Exhibit B** attached to the proposed order as satisfied, in full or in part (individually, a “**Claim**”, and collectively, the “**Claims**”).

¹ Capitalized terms used but not defined herein have the meanings ascribed to them in the Debtors’ Second Amended Joint Plan (the “**Plan**”).



Resolving the Objection

2. **Parties Required to File a Response.** If you disagree with the Objection filed with respect to any of your claims, you may file a response (each, a “**Response**”) with the Court in accordance with the procedures described below and appear at the Hearing (as defined herein).

3. **Response Contents.** Each Response should contain the following (at a minimum):

- a. a caption stating the name of the Court, the name of the Debtors, the case number, and the Objection and claim or claims within the Objection to which the Response is directed;
- b. a concise statement setting forth the reasons why the Court should not grant the Objection with respect to such claim(s), including the factual and legal bases upon which you rely in opposing the Objection;
- c. copies of documentation or other evidence of your claim (not previously filed with proof of such claim) on which your Response is based (excluding confidential, proprietary, or other protected information, copies of which must be provided to the counsel to the Plan Administrator, subject to appropriate confidentiality constraints, if any); and
- d. the following contact information:
 - (i) your name, address, telephone number, and email address or the name, address, telephone number, and email address of your attorney or designated representative to whom the attorneys for the Plan Administrator should serve a reply to the Response, if any; or
 - (ii) the name, address, telephone number, and email address of the party with authority to reconcile, settle, or otherwise resolve the objection on your behalf (to the extent different from the information detailed in paragraph 3(d)(i) above).

4. **Response Deadline.** Your Response must be filed with the Court and served so as to be *actually received* by **11:59 p.m. (Central Time) on January 6, 2022** (the “**Response Deadline**”).

5. **Failure to Respond.** A Response that is not filed and served in accordance with the procedures set forth herein may not be considered by the Court at the Hearing. **Absent an agreement with the Plan Administrator resolving the Objection to a claim, failure to timely file and serve a Response as set forth herein and appear at the**

Hearing may result in the Court granting the Objection without further notice or hearing.
Upon entry of an order, you will be served with a notice of entry, and a copy, of the order.

Hearing on the Objection

6. **Date, Time, and Location.** If necessary, a hearing (the “Hearing”) on the Objection will be held on **January 13, 2022 at 2:00 p.m. (Central Time) in the United States Bankruptcy Court for the Eastern District of Missouri, 5th Floor, North Courtroom, Thomas F. Eagleton United States Courthouse, 111 South Tenth Street, St. Louis, Missouri.** Such Hearing may be adjourned from time to time in these chapter 11 cases in the Plan Administrator’s sole discretion. **You must attend the Hearing if you disagree with the Objection and have filed a Response.** If you file a Response in accordance with the response procedures herein, but such Response is not resolved prior to the Hearing, and you appear at the Hearing, the Objection may be heard at the Hearing or adjourned to a subsequent hearing in the Plan Administrator’s sole discretion. If a subsequent hearing is determined to be necessary, the Plan Administrator will file with the Court and serve you with a notice of the subsequent hearing (the date of which will be determined in consultation with the affected claimant(s)).

Halperin as Plan Administrator (the “**Plan Administrator**”) under the *Amended Joint Chapter 11 Plan of Briggs & Stratton Corporation and its Affiliated Debtors*, dated November 9, 2020 [Docket No. 1226] (the “**Plan**”),¹ respectfully represents as follows in support of this omnibus objection to scheduled claims (the “**Objection**”) on grounds that such

scheduled claims have been either fully satisfied (the “**Fully Satisfied Claims**,” and such claimants, the “**Fully Satisfied Claimants**”) or partially satisfied (the “**Partially Satisfied Claims**,” and such claimants, the “**Partially Satisfied Claimants**”).² Lists of the identified Fully Satisfied Claims and Partially Satisfied Claims (collectively, the “**Satisfied Claims**” and such claimants collectively, the “**Satisfied Claimants**”) are attached hereto as **Exhibit A** and **Exhibit B**, respectively. Each Exhibit is then further subcategorized by Debtor, in accordance with the headers to each Exhibit.

In further support of the Objection, attached hereto as **Exhibit C** is the *Declaration of Alan D. Halperin in Support of the Plan Administrator’s Thirty-Second Omnibus Objection to Claims (Satisfied Scheduled Claims)* (the “**Halperin Claims Declaration**”):

Background

1. On July 20, 2020 (the “**Petition Date**”), the Debtors each commenced with this Court a voluntary case under title 11 of the United States Code (the “**Bankruptcy Code**”). The Debtors are authorized to continue to operate their business and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

2. On August 5, 2020, the United States Trustee appointed an official committee of unsecured creditors (the “**Creditors’ Committee**”) in these chapter 11 cases pursuant to section 1102 of the Bankruptcy Code. No trustee or examiner has been appointed in these chapter 11 cases. The Debtors’ chapter 11 cases are being jointly administered for

² In other circumstances, representatives of the Wind-Down Estates would amend their Schedules instead of bringing an omnibus claims objection motion such as this Objection. In this instance, as the Wind-Down Estates are post-confirmation and the Plan Administrator’s appointment only became effective contemporaneous with the Effective Date, the Plan Administrator believes that the Objection is the appropriate vehicle to achieve reconciliation of the Satisfied Claims. The vast majority of the Satisfied Claims were paid, in full or in part, in connection with an Order of this Court (whether a “First Day Order” or in connection with assumption of a contract during the sale process); accordingly, changes do not represent errors in the Debtors’ original Schedules, but rather changes due to progress in administering the Wind-Down Estates.

procedural purposes only pursuant to Rule 1015(b) of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”) and Rule 1015(b) of the Local Rules of Bankruptcy Procedure for the Eastern District of Missouri (the “**Local Rules**”).

3. On September 15, 2020, the Court entered an order authorizing the Debtors to sell substantially all of their assets³ to Bucephalus Buyer, LLC (the “**Purchaser**”) and on September 21, 2020, the Debtors closed the Sale Transaction.⁴ On December 16, 2020, the Debtors filed the Plan, which was confirmed by the *Findings of Fact, Conclusions of Law, and Order Confirming the Plan* on December 18, 2020 [Docket No. 1485] (the “**Confirmation Order**”).

4. The Effective Date of the Plan occurred on January 6, 2021 and the *Notice of Entry of Order Confirming the Plan and Occurrence of the Effective Date* [Docket No. 1538] was filed, at which time the Creditors’ Committee was relieved of its duties and the Plan Administrator took over the administration of the Wind-Down Estates in accordance with the Plan. The Wind-Down Estates continue to honor their post-closing sale obligations, wind down the estates, and otherwise work on concluding these chapter 11 cases.

5. On February 12, 2020, the Bankruptcy Court entered that certain *Order Approving (I) Claims Objection Procedures; (II) Claims Hearing Procedures; and (III) Granting Related Relief* [Docket No. 1614] (the “**Omnibus Procedures Order**”), which, among other things, increased the number of claims authorized to be filed in an omnibus claim objection such as this Objection to three hundred fifty (350) Claims.

6. On their Schedules (as defined herein), the Debtors identified amounts owed to specific creditors (the “**Scheduled Claims**,” and together with the Proofs of Claim, the “**Claims**”) as of the Petition Date. Based on his review to date, the Plan Administrator has identified certain of the Scheduled Claims, for which no proof of claim was filed, as Satisfied Claims because they were paid either in full or in part after the Petition Date in accordance with the administration of the Wind-Down Estates.

Jurisdiction

7. The Court has jurisdiction to consider this matter pursuant to 28 U.S.C. §§ 157 and 1334. This is a core proceeding pursuant to 28 U.S.C. § 157(b). Venue is proper before the Court pursuant to 28 U.S.C. §§ 1408 and 1409.

Relief Requested

8. Pursuant to Bankruptcy Rules 2002(m) and 9007, the Plan Administrator respectfully requests entry of an order (the “**Proposed Order**”)⁵, for which this Objection serves as notice and an opportunity to be heard, (1) deeming the Fully Satisfied Claims listed on **Exhibit A** as satisfied in full and (2) deeming the Partially Satisfied Claims listed on **Exhibit B** as satisfied to the extent reflected therein.

Claims Reconciliation

9. On August 23, 2020, the Debtors filed their schedules of assets, liabilities, current income, expenditures, executory contracts, and unexpired leases and statements of financial affairs, as required by section 521 of the Bankruptcy Code [Docket Nos. 555–559] (collectively, the “**Schedules**”).

10. On August 24, 2020, the Court entered an order [Docket No. 564] (the “**Bar Date Order**”), which, among other things, established (a) October 7, 2020 as the deadline for all non-governmental entities holding or wishing to assert a “claim” (as defined in section 101(5) of the Bankruptcy Code) against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing (the “**General Bar Date**”), and (b) January 19, 2021 as the deadline for all governmental entities holding or wishing to assert a “claim” against any of the Debtors that arose before the Petition Date to file a proof of such claim in writing.

11. As of the date hereof, approximately 3,000 proofs of claim (the “**Proofs of Claim**”) have been filed against the Debtors. The Plan Administrator and his advisors have been working diligently to review these Proofs of Claim, including any supporting documentation filed therewith, along with Debtors’ books and records. Further, the Debtors scheduled over 8,000 Scheduled Claims as part of the Schedules, which Scheduled Claims were reconciled (and to some extent, continue to be reconciled) by the Plan Administrator in connection with his duties. For the reasons set forth below, and based on his review to date, the Plan Administrator has determined that the Scheduled Claims objected to herein should be deemed satisfied in whole or in part, for purposes of additional distributions.

12. The Plan Administrator’s professionals and consultants have maintained books and records that reflect, among other things, the Debtors’ liabilities and the amounts thereof owed to their creditors (the “**Books and Records**”). The Plan Administrator and his professionals are reviewing and reconciling the Proofs of Claim filed by creditors with the Books and Records, as well as the Debtor’s Schedules. In connection therewith, the Plan Administrator and his professionals have: (1) reviewed the Satisfied Claims and concluded each Satisfied

Claim is appropriately objected to as the Debtors or the Wind-Down Estates have made either full or partial payment on account of these Satisfied Claims.

Relief Requested Should Be Granted

13. The Plan Administrator asserts that given that this Objection has been timely served on each of the Satisfied Claimants whose Satisfied Claims are affected by the relief sought herein, the notice intended by sections 2002(m) and 9007 of the Bankruptcy Code has been satisfied, and all parties-in-interest have had sufficient time to respond in the event they disagree with the relief requested. Given that the Plan Administrator had no role in the prepetition affairs of the Debtors or the pre-confirmation administration of the Estates, the Plan Administrator posits that this Objection provides the affected parties with superior notice of the proposed treatment of their Satisfied Claims than would a purported amendment to the Schedules. The Plan Administrator submits that the relief requested herein is in the best interests of the Wind-Down Estates, their creditors, and all parties-in-interest.

14. **Exhibit A**, attached hereto, identifies Fully Satisfied Claims that have been satisfied in full through authorized payments made by the Debtors or the Wind-Down Estates and should therefore be deemed satisfied for purposes of additional distributions to creditors.

15. **Exhibit B**, attached hereto, identifies Partially Satisfied Claims that have been partially satisfied through authorized payments made by the Debtors or the Wind-Down Estates and should therefore be deemed satisfied in part, and the claims register should be amended to reflect the amount that remains unpaid.

Reservation of Rights

16. Nothing contained herein is intended to be or shall be deemed as (i) an admission as to the validity of any claim against the Debtors or the Wind-Down Estates, (ii) a waiver or limitation of rights to dispute the amount of, basis for, or validity of any claim, (iii) a waiver of rights under the Bankruptcy Code or any other applicable nonbankruptcy law, (iv) an agreement or obligation to pay any claims, (v) a waiver of any claims or causes of action which may exist against any creditor or interest holder, or (vi) an approval, assumption, adoption, or rejection of any agreement, contract, lease, program, or policy under section 365 of the Bankruptcy Code.

Notice

17. Notice of this Objection will be provided to (i) the Office of the United States Trustee for the Eastern District of Missouri (Attn: Sirena Wilson, Esq.); (ii) the Fully Satisfied Claimants and the Partially Satisfied Claimants; (iii) any other party that has requested notice pursuant to Bankruptcy Rule 2002; and (iv) any other party entitled to notice pursuant to the Omnibus Procedures Order (collectively, the “**Notice Parties**”).

No Previous Request

18. No previous request for the relief sought herein has been made by the Debtors or the Plan Administrator to this or any other court.
