**NOTICE OF UNCLAIMED PROPERTY AND REVERSION OF

PLEASE TAKE NOTICE that, on December 18, 2020, the United States Bankruptcy Court for the District of Delaware entered an Order confirming the Second Amended Joint Chapter 11 Plan of Briggs & Stratton Corporation and its Affiliated Debtors (the “Plan”) [Docket No. 1485]. The Plan became effective on January 6, 2021 [Docket No. 1538], and Alan D. Halperin was appointed as Plan Administrator (the “Plan Administrator”).

PLEASE TAKE FURTHER NOTICE that, Section 5.7(b) of the Plan provides, in relevant part, that:

holders of claims shall deliver Form W-9 (or, if the payee is a foreign Person, an applicable Form W-8) to the Wind-Down Estates, unless such Person is exempt under the Tax Code and so notifies the Plan Administrator. If such request is made by the Plan Administrator or the Wind-Down Estates, or such other Person designated by the Plan Administrator or the Wind-Down Estates, and the holder fails to comply within ninety (90) days after not less than two (2) requests have been made, the amount of such distribution shall irrevocably revert to the applicable Wind-Down Estate and any Claim in respect of such distribution shall be forever barred from assertion against any Debtor, the applicable Wind-Down Estate and their respective property.



PLEASE TAKE FURTHER NOTICE that, in accordance Section 5.7(b) of the Plan, the Plan Administrator requested the required tax documents from the claimants by letter on or about September 1, 2021 and by a second letter on or about December 15, 2021. Attached hereto as **Schedule 1** is a list that identifies Claims for which no Form W-9 or Form W-8 has been received. In accordance with Section 5.7(b) of the Plan, distributions on such Claims are forever barred.

PLEASE TAKE FURTHER NOTICE that, Section 6.11 of the Plan provides, in relevant part, that:

any undeliverable distributions or unclaimed distributions shall remain in the possession of the Debtors or the Wind-Down Estates, as applicable, until such time as a distribution becomes deliverable or the holder accepts the distribution, or such distribution reverts back to the Debtors or the Wind-Down Estates....Such distributions shall be deemed unclaimed property under section 347(b) of the Bankruptcy Code at the expiration of three hundred and sixty-five (365) days from the date of distribution. After such date all unclaimed property or interest in property shall irrevocably revert to the Wind-Down Estates or the Plan Administrator, as applicable, and the Claim of any other holder to such property or interest in property shall be discharged and forever barred.

PLEASE TAKE FURTHER NOTICE that attached hereto as **Schedule 2**, is a list that identifies the Claims for which distributions were made more than 365 days ago and remain unclaimed. In accordance Section 6.11 of the Plan, the Claims listed on Schedule 2 are discharged and forever barred.
