#### CERTIFICATION OF JAMES LEE REGARDING THE SOLICITATION OF VOTES AND TABULATION OF BALLOTS CAST ON THE FOURTH AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION OF CANO HEALTH, INC. AND ITS AFFILIATED DEBTORS

I, James Lee, declare, under the penalty of perjury, that the following is true and correct:

- 1. I am a Vice President of Public Securities Services at Kurtzman Carson Consultants, LLC dba Verita Global ("Verita"), located at 222 North Pacific Coast Highway, Suite 300, El Segundo, California 90245. I am over the age of eighteen (18) years and not a party to the above-captioned action.
- 2. I submit this voting certification (this "Certification") with respect to the solicitation of votes and the tabulation of Ballots cast on the Fourth Amended Joint Chapter 11 Plan of Reorganization of Cano Health, Inc. and Its Affiliated Debtors [Docket No. 864] (the "Plan").<sup>2</sup> Except as otherwise noted, all facts set forth herein are based on (a) my personal knowledge, (b) knowledge that I acquired from individuals under my supervision, including Sydney Reitzel, Director of Corporate Restructuring Services, who assisted in the service and

tabulation described herein, and (c) my review of the relevant documents. I am authorized to submit this Certification on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.

3. By orders dated, February 6, 2024 [Docket No. 79] and March 5, 2024 [Docket No. 252], respectively (collectively, the "Retention Orders"), the United States Bankruptcy Court for the District of Delaware (the "Court") authorized Verita's retention as (a) claims and noticing agent in the Chapter 11 Cases and (b) administrative advisor to the above-captioned debtors and debtors in possession (collectively, the "Debtors"). The Retention Orders authorize Verita to assist the Debtors with, among other things, (a) service of solicitation materials to the parties entitled to vote to accept or reject the Plan, and (b) tabulation of votes cast with respect thereto. As set forth in the applications and declarations submitted in connection with the Retention Orders, Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject proposed chapter 11 plans.

#### A. Service and Transmittal of Solicitation Packages and Related Materials

4. Pursuant to the Order (I) Approving Proposed Disclosure Statement and Form and Manner of Notice of Disclosure Statement Hearing, (II) Establishing Solicitation and Voting Procedures, (III) Scheduling Confirmation Hearing, (IV) Establishing Notice and Objection Procedures for Confirmation of Proposed Plan, and (V) Granting Related Relief [Docket No. 865] (the "Disclosure Statement Order") entered on May 21, 2024, the Court established, among other things, certain solicitation and voting tabulation procedures with respect to the Plan (the "Solicitation and Voting Procedures"). Verita adhered to the Solicitation and Voting Procedures set forth in the Disclosure Statement Order and in the Ballots distributed to parties entitled to vote.

5. The Disclosure Statement Order established May 17, 2024 at 5:00 p.m. (prevailing Eastern Time) as the record date for determining which holders of Claims were entitled to vote on the Plan (the "Voting Record Date"). Pursuant to the Plan and the Solicitation and Voting Procedures, only holders of Claims as of the Voting Record Date in the following classes were entitled to vote to accept or reject the Plan with respect to the applicable Debtors (collectively, the "Voting Classes"):

Plan Class	Class Description
3	First Lien Claims
4	RSA GUC Claims
5	Non-RSA GUC Claims
6	Convenience Claims

No other classes were entitled to vote on the Plan.

- 6. In accordance with the Solicitation and Voting Procedures, Verita worked closely with the Debtors and their advisors to identify the Holders entitled to vote, and on May 24, 2024, Verita caused the Solicitation Packages to be served on all known holders of Claims entitled to vote on the Plan as of the Voting Record Date.
- 7. On May 24, 2024, Verita also caused the appropriate Unimpaired or Impaired Notice of Non-Voting Status Packages to be served, in lieu of a Solicitation Package, on all known holders of Claims or Interests in Class 1 (Other Priority Claims), Class 2 (Other Secured Claims), Class 8 (Subordinated Claims), Class 11 (Existing PCIH Interests), and Class 12 (Existing CHI Interests) as of the Voting Record Date.

- 8. Furthermore, on May 24, 2024, Verita caused the Confirmation Hearing Notice to be served on the creditor matrix and all other parties required to receive such notice pursuant to the Disclosure Statement Order.
- 9. In accordance with the Disclosure Statement Order, Solicitation Packages, the applicable Notice of Non-Voting Status, or other Plan-related materials were not distributed to holders of Claims or Interests in Class 7 (Intercompany Claims), Class 9 (Existing Subsidiary Interests), and Class 10 (Existing CH LLC Interests).
- 10. A certificate of service evidencing distribution of the foregoing materials was filed with the Court on June 13, 2024 [Docket No. 1006]. During the voting period, Verita forwarded materials to parties whose packages were returned with a forwarding address. A supplemental certificate of service evidencing the foregoing was filed with the Court [Docket No. 1053].
- 11. On May 24, 2024, Verita posted links to the electronic versions of the Plan, the Disclosure Statement, the Disclosure Statement Order, and the Confirmation Hearing Notice on the public access website at www.veritaglobal.net/CanoHealth. Furthermore, on June 14, 2024, Verita posted a link to the electronic version of the Notice of Filing of Plan Supplement on the public access website.
- 12. On May 29, 2024, the Confirmation Hearing Notice was published in *The Wall Street Journal*, *Miami Herald*, and *Sun Sentinel*. An affidavit evidencing the foregoing was filed on June 6, 2024 [Docket No. 983].

#### **B.** The Tabulation Process

13. Verita worked closely with the Debtors' advisors to create a voting database reflecting the names and addresses of holders of Claims and Interests, the classification of Claims

and Interests, and voting amounts for the Voting Classes. In so doing, Verita relied on, among other things, the following information:

- a. the Debtors' Schedules of Assets and Liabilities;
- b. the claims information reflected on the register of filed proofs of claim, to identify and solicit holders of Claims and Interests in the Voting Classes;
- c. lender registers from Credit Suisse AG, Cayman Islands Branch, as administrative agent and collateral agent under the CS Credit Agreement, and JPMorgan Chase Bank, N.A., as administrative agent and collateral agent under the Side-Car Credit Agreement, as of the Voting Record Date to identify the holders of Class 3 (First Lien) <sup>3</sup> and Class 4 (RSA GUC: First Lien Deficiency Claims) entitled to vote to accept or reject the Plan; and
- d. security position reports provided by the Depository Trust Company as of the Voting Record Date to identify the banks and brokerage firms of Class 4 (RSA GUC: Senior Notes) whose Beneficial Holders are entitled to vote to accept or reject the Plan.
- 14. In accordance with the Solicitation and Voting Procedures, Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. Each Ballot submitted to Verita was date-stamped, scanned, assigned a Ballot number, entered into Verita's voting database, and processed in accordance with the Solicitation and Voting Procedures. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation and Voting Procedures, (b) executed by the relevant Holder entitled to vote on the Solicited Plan (or such Holder's authorized representative), (c) returned to Verita via an approved method of delivery set forth in the Solicitation and Voting Procedures unless the delivery method requirement was waived by the Debtors, and (d) received by Verita on or before

Voting amounts were updated and Ballots re-served on June 14, 2024, to reflect interest accrued as of February 3, 2024, and to give effect to the correct proportional allowance amount. Of the re-served Ballots, no Class 3 holders submitted Ballots after the Voting Deadline.

the Voting Deadline<sup>4</sup> (i.e., June 21, 2024 at 5:00 p.m. (prevailing Eastern Time)), which was established by the Disclosure Statement Order.

15. All valid Ballots cast by Holders entitled to vote in the Voting Classes and received by Verita on or before the Voting Deadline or, in the case of any Ballots with deficiencies, to the extent such deficiencies were waived by the Debtors, were tabulated pursuant to the Solicitation and Voting Procedures.

#### C. Tabulation Results

- 16. The tabulation results reflect that the Voting Classes voted as follows:
  - a. Class 3 (First Lien Claims) and Class 4 (RSA GUC Claims) voted to accept the Plan at each of the thirty-six Debtors that have Class 3 and Class 4 Claims;
  - b. Class 5 (Non-RSA GUC Claims) voted to accept the Plan at all but eleven of the Debtors;<sup>5</sup> and
  - c. Class 6 (Convenience Claims) voted to accept the Plan at each of the Debtors except for Debtor Cano Health of Florida, LLC.

A chart setting forth these results is attached hereto as **Exhibit A**.

- 17. The final tabulation of votes cast by timely and properly completed Ballots received by Verita is attached hereto as **Exhibit B**. The detailed Ballot reports for all Voting Classes are attached hereto as **Exhibit B-1** through **Exhibit B-4**.
- 18. Accordingly, as set forth in **Exhibit A**, the Debtors received sufficient votes to obtain the acceptance of at least one Impaired accepting Class on the Plans for forty of the forty-

The Class 5 Ballot returned by MedCloud Depot, LLC (No. 367 filed) was received shortly after the Voting Deadline and was included in the tabulation. No other late Ballots were included in tabulation.

Class 5 (Non-RSA GUC Claims) voted to reject the Plan for the following eleven Debtors: (i) Cano Health, Inc., (ii) DGM MSO, LLC, (iii) Orange Accountable Care Organization of South Florida LLC, (iv) Orange Accountable Care Organization, LLC, (v) Orange Care Group South Florida Management Services Organization, LLC, (vi) Orange Care IPA of New Jersey, LLC, (vii) Orange Care IPA of New York, LLC, (viii) Orange Healthcare Administration, LLC, (ix) Physicians Partners Group of FL, LLC, (x) Total Care ACO, LLC, and (xi) University Health Care Pharmacy, LLC (collectively, the "Class 5 Rejecting Debtors").

eight Debtors. In addition, of the remaining eight Debtors, five of those Debtors have no asserted Impaired Claims (other than scheduled intercompany claims).

19. The remaining three Debtors where claims were asserted but no votes were received are: (i) Cano Health Illinois 1 MSO, LLC, (ii) Cano Health CA1, LLC, and (iii) CHPR MSO LLC. Cano Health Illinois 1 MSO, LLC and Cano Health CA1, LLC, have only one allowed Claim comprising the entirety of Class 5 (Non-RSA GUC Claims) and Class 6 (Convenience Claims), respectively, and no Claims in any other Classes, while CHPR MSO LLC has one incomplete asserted Claim, and no Claims in any other Classes. Verita distributed Solicitation Packages, including Ballots, to the two Claim holders at Cano Health Illinois 1 MSO, LLC and Cano Health CA1, LLC, and the Notice of Confirmation Hearing to the Claim holder at CHPR MSO LLC, which included the Voting Deadline and procedures for objecting to the Plan and disputing classification of Claims.

#### **D.** Ballots That Were Not Counted

20. A report of the Ballots excluded from the final tabulation is attached hereto as **Exhibit C**, along with the reason for exclusion.

#### **E. Opt-Out Election**

21. Verita reviewed and documented which holders of Claims elected to opt out of the Third-Party Release. A report of all Holders who elected to opt out of the Third-Party Release is attached hereto as **Exhibit D**. For the avoidance of doubt, this Voting Certification does not certify the validity or enforceability of any opt-out elections received, including those reported on
