On August 12, 2024, Ernst & Young LLP (the “**Applicant**”) filed the *Fifth Monthly Fee Statement of Ernst & Young LLP as Audit Services Provider to the Debtors for Compensation for Professional Services Rendered and Reimbursement of Expenses Incurred for the Period from June 1, 2024 through and including June 28, 2024* [Docket No. 1319] (the “**Application**”) with the United States Bankruptcy Court for the District of Delaware (the “**Court**”).

On August 13, 2024, the Court entered an order closing the chapter 11 cases of CHI’s debtor affiliates, (collectively, the “**Closed Case Debtors**”). 3. The Application was filed and served in accordance with the *Order Pursuant to 11 U.S.C. §§ 105(a), 330, and 331 and Fed. R. Bankr. P. 2016 (I) Establishing Procedures for Interim Compensation and Reimbursement of Expenses of Professionals and (II) Granting Related Relief* [Docket No. 243] (the “**Interim Compensation Order**”). Pursuant to the Interim Compensation Order and the *Order Pursuant to 11 U.S.C. §§ 327 and 328 and Fed. R. Bankr. P. 2014(a) and 2016 (I) Authorizing the Retention and Employment of Ernst & Young LLP as Audit Services Provider to the Debtors Effective as of the Petition Date, and (II) Granting Related Relief* [Docket No. 247], the Reorganized Debtors are authorized and directed to pay the Applicant eighty percent (80%) of the fees and one hundred percent (100%) of the expenses requested in the Application upon the filing of this certification of no objection without the need for a further order of the Court.
