3. To the extent not already paid pursuant to the Interim Compensation Order, the Reorganized Debtors (as defined in the Plan) are authorized to pay each of the Applicants one-hundred percent (100%) of the fees and one-hundred percent (100%) of the expenses listed on the attached <u>Exhibit A</u> under the columns labeled "Final Fees Approved" and "Final Expenses Approved", as applicable, in satisfaction of the allowed fees and expenses, for services rendered and expenses incurred during the Compensation Period.

4. This Order shall be deemed a separate order with respect to each of the Final Fee Applications. Any stay of this Order pending appeal with respect to any one Applicant shall only
