On December 22, 2024, CCA Construction Inc. (CCA) announced it has taken important strategic actions in connection with a legal dispute related to the development and construction of the Baha Mar resort in The Bahamas. The defendants in the case – CCA, CCA Bahamas Ltd. and CSCEC Bahamas, Ltd. – believe that the recent decision by a New York court to award damages to Baha Mar's former developer is wrong and are seeking to have it overturned on appeal.
