The above-captioned debtor and debtor in possession (“CCA” or the “**Debtor**”) respectfully requests that the time period to notice a hearing on the *Debtor’s Motion for Entry of an Order (I) Approving the Disclosure Statement on an Interim Basis; (II) Scheduling a Combined Hearing on Final Approval of the Disclosure Statement and Plan Confirmation and Deadlines Related Thereto; (III) Approving the Solicitation, Notice, and Tabulation Procedures and the Forms Related Thereto; and (IV) Granting Related Relief* (the “**Motion**”)², filed substantially contemporaneously herewith, as required by Fed. R. Bankr. P. 2002 be shortened pursuant to Fed. R. Bankr. P. 9006(c)(1), and respectfully submits:³

1. **A shortened time hearing is requested because:** As the Court is aware, CCA’s chapter 11 case was precipitated by a crippling judgment that has since been settled, following Court-ordered mediation, in accordance with the terms of a global settlement agreement approved by the Court. Following entry of the December 3, 2025 order approving the global settlement, *see* Docket No. 591, in an effort to bring this chapter 11 case to an efficient conclusion, CCA and its professionals have worked, and continue to work, in parallel, to (a) perform under, and implement, the terms of that agreement, including (i) making arrangements for the dismissal of certain pending proceedings upon the settlement effective date as well as (ii) settlement payment mechanics, and (b) advance confirmation-related workstreams, including (i) filing a motion to further extend the Debtor’s exclusivity periods, *see* Docket No. 615, (ii) extending the maturity date of the Debtor’s postpetition financing for an additional six (6) months in accordance with its terms, and (iii) drafting the Debtor’s disclosure statement, plan, and related papers. The Debtor’s

professionals are advancing the numerous workstreams as quickly as possible under the circumstances and submit that expeditious resolution of the plan process will avoid incurrence of unnecessary costs and facilitate a value-maximizing conclusion to this chapter 11 case for the benefit of all stakeholders.

2. **State the hearing dates requested:** CCA respectfully requests that the Court hold a hearing (including an electronic or telephonic hearing) to consider granting the interim relief requested in the Motion at the next omnibus hearing scheduled in this chapter 11 case, which is January 7, 2026, at 2:00 p.m. prevailing Eastern Time, *see* Docket No. 448, or at the Court's earliest availability.

3. Reduction of the time period for a hearing on the Motion is not prohibited under Fed. R. Bankr. P 9006(c)(1).

WHEREFORE, CCA respectfully requests entry of the proposed order attached hereto as Exhibit A shortening time, in substantially the form submitted herewith, granting the relief requested herein and such other relief as is just and proper under the circumstances.
