4. Consistent with its retention as Claims and Noticing Agent and Administrative Advisor, Verita is charged with, among other things, printing and distributing Solicitation Packages² to creditors and other interested parties pursuant to the solicitation and voting procedures included within the *Order (I) Approving the Disclosure Statement on an Interim Basis; (II) Scheduling a Combined Hearing on Final Approval of the Disclosure Statement and Plan Confirmation and Deadlines Related Thereto; (III) Approving the Solicitation, Notice, and Tabulation Procedures and the Forms Related Thereto; and (IV) Granting Related Relief* [Docket No. 647] (the “Interim Approval and Procedures Order”) entered on January 7, 2026.

Dear Holders of Claims entitled to vote on the Plan,

You have received this letter and the enclosed materials because you are entitled to vote on the *Chapter 11 Plan of CCA Construction, Inc.* [Docket No. 649] (as modified, amended, or supplemented from time to time, the “Plan”).¹

CCA Construction, Inc. (the “Debtor”) filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code in the United States Bankruptcy Court for the District of New Jersey (the “Bankruptcy Court”) on December 22, 2024.

On January 7, 2026, the Bankruptcy Court entered an order [Docket No. 647] (the “Interim Disclosure Statement Order”) (a) authorizing the Debtor to solicit acceptances for the Plan; (b) approving the *Disclosure Statement for the Chapter 11 Plan for CCA Construction, Inc.* [Docket No. 648] (as modified, amended, or supplemented from time to time, the “Disclosure Statement”) as containing “adequate information” pursuant to section 1125 of the Bankruptcy Code on an interim basis; (c) approving the solicitation materials and documents to be included in the solicitation packages (the “Solicitation Packages”); and (d) approving procedures for soliciting, receiving, and tabulating votes on the Plan and for filing objections to the Plan.

YOU ARE RECEIVING THIS LETTER BECAUSE YOU ARE ENTITLED TO VOTE ON THE PLAN. THEREFORE, YOU SHOULD READ THIS LETTER CAREFULLY AND DISCUSS IT WITH YOUR ATTORNEY. IF YOU DO NOT HAVE AN ATTORNEY, YOU MAY WISH TO CONSULT ONE.

In addition to this cover letter, the enclosed materials comprise your Solicitation Package, and were approved by the Bankruptcy Court for distribution to Holders of Claims in connection with the solicitation of votes to accept the Plan. The Solicitation Package consists of the following, certain of which may be a website link, as applicable:

1. a Ballot, together with detailed voting instructions, instructions on how to submit the Ballot, and a pre-addressed, postage prepaid return envelope;
2. the Confirmation Hearing Notice;
3. the Disclosure Statement as approved by the Bankruptcy Court (and exhibits thereto) (provided electronically at: <https://www.veritaglobal.net/ccaconstruction>);
4. the Plan (provided electronically at: <https://www.veritaglobal.net/ccaconstruction>);
5. Interim Disclosure Statement Order (without exhibits) (provided electronically at: <https://www.veritaglobal.net/ccaconstruction>); and
6. any additional documents the Bankruptcy Court has ordered to be made available to the Voting Class.

The Debtor has approved the filing of the Plan and the solicitation of votes to accept the Plan. The Debtor

believes that the acceptance of the Plan is in the best interests of its estate, Holders of Claims, and all other parties-in-interest. Moreover, the Debtor believes that any alternative other than Confirmation of the Plan could result in extensive delays and increased administrative expenses, which, in turn, likely would result in smaller distributions (or no distributions) on account of Claims asserted in the Chapter 11 Case.
