**STIPULATION AND AGREED ORDER RESOLVING AMENDED MOTION OF  
NADER TAVAKOLI, ACTING SOLELY AS PLAN ADMINISTRATOR, (I) FOR  
ENTRY OF AN ORDER DETERMINING 2018 AD VALOREM TAX LIABILITIES  
PURSUANT TO 11 U.S.C. § 505; AND (II) OBJECTING TO THE TAXING  
AUTHORITIES’ PROOFS OF CLAIM**

This stipulation and agreed order (the “Stipulation and Agreed Order”) is made by and between Nader Tavakoli, solely in his capacity as Lead Member and Chairman of the Plan Administrator Committee of Cobalt International Energy, Inc., *et al.* (the “Plan Administrator”), on the one hand, and Harris County<sup>2</sup>, Cypress-Fairbanks Independent School District (“Cy-Fair ISD”), Sheldon Independent School District (“Sheldon ISD”), Spring Branch Independent School District (“Spring Branch ISD”), and the City of Houston (and together with Harris County, Cy-Fair ISD, Sheldon ISD, and Spring Branch ISD, the “Taxing Authorities”), on the other hand.

The Plan Administrator and the Taxing Authorities are collectively referred to herein as the “Parties.”

**WHEREAS**, on March 26, 2019, the Plan Administrator filed *Amended Motion of Plan Administrator, Acting Solely as Plan Administrator, (I) for Entry of an Order Determining 2018 Ad Valorem Tax Liabilities Pursuant to 11 U.S.C. § 505; and (II) Objecting to the Taxing Authorities’ Proofs of Claim* [Docket No. 1265] (the “Motion”);

**WHEREAS**, on April 16, 2019, the Taxing Authorities filed their responses and objections to the Motion [Docket Nos. 1274 and 1275] (the “Contested Matter”); and

**WHEREAS**, the Parties have been engaged in good faith negotiations regarding the Motion and the relief sought therein and have reached an agreement fully and finally resolving the Motion and Contested Matter and the Taxing Authorities’ respective asserted claims for 2018 personal property taxes, as set forth herein.

**NOW, THEREFORE**, in consideration of the foregoing recitals, which are incorporated into this Stipulation and Agreed Order, the Parties hereby stipulate and agree as follows:

1. This Stipulation and Agreed Order shall fully and finally resolve the Motion and the Contested Matter and the Taxing Authorities’ respective asserted claims for 2018 personal property taxes.

2. The fair cash market value of the Memorial City Personal Property<sup>3</sup> located at 920 Memorial City Way, Suite 100, Houston, Texas 77024 (Account No. 2163136/2216313600000) for the 2018 tax year is hereby set at \$930,000, as agreed to by and between the Plan Administrator and the Harris County Appraisal District.

3. The fair cash market value of the Eldridge Personal Property located at 6401 North Eldridge Parkway, Houston, Texas 77050 (Account No. 2067878/2206787800000) for the

2018 tax year is hereby set at \$3,150,000, as agreed to by and between the Plan Administrator and the Harris County Appraisal District.

4. The fair cash market value of the East Mount Personal Property located at 9518 East Mount Houston Road, Houston, Texas 77050 (Account No. 2208031300000) for the 2018 tax year is hereby set at \$5,565,975, as agreed to by and between the Plan Administrator and the Harris County Appraisal District.

5. The fair cash market value of the Sheldon Personal Property located at 10222 Sheldon Road, Houston, Texas 77049 (Account No. 00002080312/2208031200000) for the 2018 tax year is hereby set at \$2,481,910, as agreed to by and between the Plan Administrator and the Harris County Appraisal District.


6. The 2018 personal property taxes due to the Taxing Authorities for each property location are set forth in **Exhibit A** attached hereto. Payment, in full by June 30, 2019, by the Plan Administrator of the 2018 personal property taxes for each property location set forth in **Exhibit A** shall fully and finally resolve the Taxing Authorities' respective asserted claims for 2018 personal property taxes (including penalties and interest) due for each such property location.

7. The Plan Administrator is hereby authorized to take all actions necessary to effectuate the terms of this Stipulation and Agreed Order.

8. The Court shall retain exclusive jurisdiction to hear and determine all matters arising from or related to the implementation, interpretation and enforcement of this Order.
