**STIPULATION TO EXTEND TIME TO FILE RESPONSE TO DEBTOR'S
MOTION TO CITY OF DETROIT'S MOTION FOR ENTRY OF AN
ORDER ENFORCING THE BAR DATE ORDER AND CONFIRMATION
ORDER AGAINST MARK CRAIGHEAD**

UPON STIPULATION of the City of Detroit and Mark Craighead, by and through their attorneys, and the Court being fully advised in the premises, as follows:

The City of Detroit filed its Motion for the Entry of an Order Enforcing the Bar Date Order and Confirmation Order Against Mark Craighead (Doc 13803) ("Motion") on October 27, 2023, and Mr. Craighead's response to the Motion is currently due within 14 days (November 10, 2023).

The deadline for Mr. Craighead to respond to the City of Detroit's motion filed in a related civil lawsuit in district court is November 17, 2023. Mr. Craighead's counsel has requested an additional 10 days to respond to the Motion to correspond with deadlines in that related civil lawsuit; counsel for the City of Detroit has agreed with the request.
