EX PARTE MOTION OF THE CITY OF DETROIT FOR ENTRY OF AN ORDER AUTHORIZING A REPLY <u>BRIEF IN EXCESS OF THE PAGE LIMIT</u>

The City of Detroit ("<u>City</u>") by its undersigned counsel, Miller, Canfield, Paddock and Stone, P.L.C., files this *ex parte* motion for entry of an order authorizing the City to file a reply in support of its *Motion for the Entry of an Order Enforcing the Bar Date Order and Confirmation Order Against Mark Craighead* ("<u>Motion</u>") [Doc. No. 13803] in excess of the page limit and states as follows:

1. On October 27, 2023, the City filed its Motion.

2. On November 20, 2023, Marc Craighead ("<u>Craighead</u>") filed a response objecting to the Motion ("<u>Response</u>"). [Doc. No. 13824].

3. Local Bankruptcy Rule 9014-1(f) limits the length of a reply brief to seven (7) pages in length, including footnotes and signatures.

4. The Response contains a discussion of whether the "fair contemplation" test is appropriate in this instance and raises other issues. A proper

reply to these issues, along with a brief review of Craighead's legal history prior to the City's bankruptcy case, requires more than the seven pages permitted.

5. In view of the complexity of these issues, the City requests that the length of its reply brief in support of its Motion be extended to 15 pages.

6. The City's counsel contacted Mr. Craighead's counsel on December 6,

2023, and Mr. Craighead's counsel does not oppose the relief sought in this motion.

WHEREFORE the City respectfully requests that the Court enter an order, substantially in the form attached as **Exhibit 1**, granting the City an enlargement of the page limit from seven to 15 pages for its reply brief.
