PLEASE TAKE FURTHER NOTICE that, as noted above, the Bidding Procedures Order established procedures for the assumption and assignment of certain executory contracts and unexpired leases (including without limitation any and all amendments, modifications, side letters, memoranda of understanding, documents incorporated be reference, attachments, and exhibits thereto) that the Debtors believe they <u>may</u> seek to assume and assign in connection with the Other Florida Assets Sale Transaction(s) (collectively, the "Designated Contracts") to a purchaser or purchasers and the determination of related Cure Costs (as defined below). Other than the Cure Costs listed on the Designated Contracts List, the Debtors are not aware of any amounts due and owing under the Designated Contracts. To the extent that the Debtors satisfy any portion of the Cure Costs subsequent to the filing of this Notice of Potential Assumption and Assignment, the Cure Costs shall be reduced accordingly.

The Sale Hearing may be adjourned from time to time without further notice other than the filing of an agenda on the docket of the Chapter 11 Cases informing parties of same. PLEASE TAKE FURTHER NOTICE that the listing of a Designated Contract on the Designated Contracts List does not constitute an admission that any Designated Contract is an executory contract or unexpired lease as contemplated by section 365(a) of the Bankruptcy Code or that the Debtors have any liability thereunder, and the Debtors expressly reserve all of their rights, claims, causes of action, and defenses with respect to the Designated Contracts listed on the Designated Contracts List and any supplement(s) thereto.

Any party requesting such Adequate Assurance Information shall have (i) with respect to any Stalking Horse Bidder, the later of (a) October 6, 2025 at 4:00 p.m. (prevailing Eastern Time) and (b) the date that is seven (7) days after receipt of the Stalking Horse Bidder's Adequate Assurance Information, or (ii) with respect to any other Bidder, October 16, 2025 at 4:00 p.m. (prevailing Eastern Time), to object on the basis of any Adequate Assurance Information that is provided.

PLEASE TAKE FURTHER NOTICE that if a counterparty to a Designated Contract does not timely file and serve a Designated Contract Objection in accordance with the Bidding Procedures Order and this Notice of Potential Assumption and Assignment, such counterparty will be deemed to have consented to the assumption and assignment of such party's Designated Contract to a Successful Bidder, notwithstanding any anti-alienation provision or other restriction on assumption or assignment in the Designated Contract, and may be forever barred from asserting any objection with regard to such assumption and assignment and/or Cure Costs set forth on the Designated Contracts List.

PLEASE TAKE FURTHER NOTICE that although the Debtors have made a good-faith effort to identify all Designated Contracts that might be assumed and assigned in connection with the Other Florida Assets Sale Transaction(s), the Debtors may discover certain additional contracts inadvertently omitted from the Designated Contracts List or one or more Successful Bidder(s) may identify other executory contracts or unexpired leases that they desire to assume and assign in connection with the Other Florida Assets Sale Transaction(s). Accordingly, the Debtors reserve the right to (i) supplement the Designated Contracts List, (ii) remove a Designated Contract from any list of contracts ultimately selected as a Designated Contract that a Successful Bidder proposes be assumed and assigned to it in connection with the Other Florida Assets Sale Transaction(s), and/or (iii) modify, with notice to any affected counterparty, the previously stated Cure Cost(s) associated with any Designated Contract.

Only those Designated Contracts that are ultimately selected for assumption and assignment in accordance with any applicable Other Florida Assets Sale Transaction will be assumed and assigned to the Successful Bidder(s).
