**NOTICE OF EXECUTORY CONTRACTS AND UNEXPIRED
LEASES THAT MAY POTENTIALLY BE ASSUMED AND ASSIGNED
IN CONNECTION WITH THE SALE OF THE DEBTORS' ASSETS
AND THE PROPOSED CURE COSTS WITH RESPECT THERETO**

YOU ARE RECEIVING THIS NOTICE (THIS “*NOTICE OF POTENTIAL ASSUMPTION AND ASSIGNMENT*”)² BECAUSE YOU MAY BE A COUNTERPARTY TO AN EXECUTORY CONTRACT OR UNEXPIRED LEASE WITH ONE OR MORE OF THE DEBTORS THAT MAY BE ASSUMED PURSUANT TO CERTAIN ASSET SALE PROCEDURES, AS DETAILED BELOW. PLEASE READ THIS NOTICE CAREFULLY AS YOUR RIGHTS MAY BE AFFECTED BY THE TRANSACTIONS DESCRIBED HEREIN.

PLEASE TAKE NOTICE that on July 29, 2025, the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”) entered an order [Docket No. 402] (the “**Bidding Procedures Order**”) approving the motion [Docket No. 299] (the “**Bidding**

Procedures Motion)³ of the debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “**Debtors**”), establishing, among other things: (i) bidding procedures (the “**Bidding Procedures**”) by which the Debtors will solicit and select the highest or otherwise best offer for the sale of substantially all or a portion of their assets (the “**Assets**”), free and clear of all liens, claims, interests, and encumbrances, through one or more sales of the Assets (each, a “**Sale Transaction**” or “**Sale**”); (ii) procedures for the assumption and assignment of executory contracts and unexpired leases, including notice of proposed cure amounts (the “**Assumption and Assignment Procedures**”); (iii) approving the form and manner of notice with respect to certain procedures, protections, schedules, and agreements described herein and attached hereto, including the Debtors’ selection of one or more stalking horse bidders (each a “**Stalking Horse Bidder**”), if any, and the provision of Bid Protections to such Stalking Horse Bidder(s), if necessary; (iv) scheduling (a) an auction if the Debtors receive one or more timely and acceptable Qualified Bids and (b) a final hearing or hearings to approve one or more Sales of the Assets; and (v) granting related relief.

PLEASE TAKE FURTHER NOTICE that on October 15, 2025, the Debtors filed the *Notice of Proposed Sale, Bidding Procedures, Auction, and Sale Hearing for the Debtors’ Mexican Assets* [Docket No. 596]⁴ regarding the sale of the Debtors’ assets and operations located in Mexico (collectively, the “**Mexican Assets**” and the sale(s) thereof, the “**Mexican Assets Sale Transaction(s)**”).

PLEASE TAKE FURTHER NOTICE that, as noted above, the Bidding Procedures Order established procedures for the assumption and assignment of certain executory contracts and unexpired leases (including without limitation any and all amendments, modifications, side letters, memoranda of understanding, documents incorporated by reference, attachments, and exhibits thereto) that the Debtors believe they may seek to assume and assign in connection with the Mexican Assets Sale Transaction(s) (collectively, the “**Designated Contracts**”) to a purchaser or purchasers and the determination of related Cure Costs (as defined below). The Debtors are parties to numerous Designated Contracts and, in accordance with the Bidding Procedures Order, hereby file this Notice of Potential Assumption and Assignment identifying (i) the Designated Contracts, which may be assumed and assigned to a Successful Bidder in connection with the Mexican Assets Sale Transaction(s) and (ii) the proposed amounts, if any, the Debtors believe are owed, as of the date of this Notice of Potential Assumption and Assignment, to the counterparties to the Designated Contracts to cure any defaults or arrears existing under the Designated Contracts (such amounts, the “**Cure Costs**”), as set forth on Exhibit 1 attached hereto (the “**Designated Contracts List**”). Other than the Cure Costs listed on the Designated Contracts List, the Debtors are not aware of any amounts due and owing under the Designated Contracts. To the extent that the Debtors satisfy any portion of the Cure Costs subsequent to the filing of this Notice of Potential Assumption and Assignment, the Cure Costs shall be reduced accordingly.

PLEASE TAKE FURTHER NOTICE that the hearing to approve the Mexican Assets Sale Transaction(s) (the “**Sale Hearing**”) is currently scheduled be held on **December 3, 2025 at 2:00 p.m. (prevailing Eastern Time)** before the Honorable Laurie Selber Silverstein, United States Bankruptcy Judge for the District of Delaware, at the Bankruptcy Court, 824 N. Market Street, 6th Floor, Courtroom No. 2, Wilmington, Delaware 19081. The Sale Hearing may be adjourned from time to time without further notice other than the filing of an agenda on the docket of the Chapter 11 Cases informing parties of same. Any adjourned hearing dates will be available on the electronic docket of the Chapter 11 Cases or on the Debtors’ case website: <https://veritaglobal.net/dolphinco>.

PLEASE TAKE FURTHER NOTICE that the listing of a Designated Contract on the Designated Contracts List does not constitute an admission that any Designated Contract is an executory contract or unexpired lease as contemplated by section 365(a) of the Bankruptcy Code or that the Debtors have any liability thereunder, and the Debtors expressly reserve all of their rights, claims, causes of action, and defenses with respect to the Designated Contracts listed on the Designated Contracts List and any supplement(s) thereto.

PLEASE TAKE FURTHER NOTICE that to the extent a counterparty to a Designated Contract objects to the proposed assumption and assignment of an applicable Designated Contract or the proposed Cure Costs, if any, such counterparty must file and serve an objection (a “**Designated Contract Objection**”), in accordance with the Bidding Procedures Order and this Notice of Potential Assumption and Assignment, not later than **November 12, 2025 at 4:00 p.m. (prevailing Eastern Time)** (the “**Assignment and Assumption Objection Deadline**”). Any Designated Contract Objection must (i) state, with specificity, the legal and factual basis for the objection, including any asserted Cure Costs, if any, (ii) include appropriate documentation in support thereof, and (iii) be filed and served on the following (the “**Objection Recipients**”): (a) counsel to the Debtors, Young Conaway Stargatt & Taylor, LLP, 1000 N. PLEASE TAKE FURTHER NOTICE THAT IF A COUNTERPARTY TO A DESIGNATED CONTRACT FILES A DESIGNATED CONTRACT OBJECTION, AND THE PARTIES ARE UNABLE TO CONSENSUALLY RESOLVE THE DISPUTE PRIOR TO THE SALE HEARING, THE AMOUNT TO BE PAID OR RESERVED WITH RESPECT TO SUCH OBJECTION WILL BE DETERMINED AT THE SALE HEARING, SUCH LATER HEARING DATE THAT THE DEBTORS DETERMINE IN THEIR DISCRETION, OR SUCH OTHER DATE DETERMINED BY THE BANKRUPTCY COURT. ALL OTHER OBJECTIONS TO THE PROPOSED ASSUMPTION AND ASSIGNMENT OF THE DEBTORS' RIGHT, TITLE, AND INTEREST IN, TO, AND UNDER THE DESIGNATED CONTRACTS WILL BE HEARD AT THE SALE HEARING.

PLEASE TAKE FURTHER NOTICE that any counterparty to a Designated Contract shall, upon request to the Debtors' counsel, be provided with Adequate Assurance Information (as defined in the Bidding Procedures) relevant to the affected counterparty as soon as practicable after it is received by the Debtors. Any party requesting such Adequate Assurance Information shall have (i) with respect to any Stalking Horse Bidder, the later of (a) **November 14, 2025 at 4:00 p.m. (prevailing Eastern Time)** and (b) **the date that is seven (7) days after receipt of the Stalking Horse Bidder's Adequate Assurance Information**, or (ii) with respect to any other Bidder, **December 1, 2025 at 4:00 p.m. (prevailing Eastern Time)**, to object on the basis of any Adequate Assurance Information that is provided.

PLEASE TAKE FURTHER NOTICE that if a counterparty to a Designated Contract does not timely file and serve a Designated Contract Objection in accordance with the Bidding Procedures Order and this Notice of Potential Assumption and Assignment, such counterparty will be deemed to have consented to the assumption and assignment of such party's Designated Contract to a Successful Bidder, notwithstanding any anti-alienation provision or other restriction on assumption or assignment in the Designated Contract, and may be forever barred from asserting any objection with regard to such assumption and assignment and/or Cure Costs set forth on the Designated Contracts List.

PLEASE TAKE FURTHER NOTICE that although the Debtors have made a good-faith effort to identify all Designated Contracts that might be assumed and assigned in connection with the Mexican Assets Sale Transaction(s), the Debtors may discover certain additional contracts inadvertently omitted from the Designated Contracts List or one or more Successful Bidder(s) may identify other executory contracts or unexpired leases that they desire to assume and assign in connection with the Mexican Assets Sale Transaction(s). Accordingly, the Debtors reserve the right to (i) supplement the Designated Contracts List, (ii) remove a Designated Contract from any list of contracts ultimately selected as a Designated Contract that a Successful Bidder proposes be assumed and assigned to it in connection with the Mexican Assets Sale Transaction(s), and/or (iii) modify, with notice to any affected counterparty, the previously stated Cure Cost(s) associated with any Designated Contract.

PLEASE TAKE FURTHER NOTICE that, in the event that the Debtors supplement the Designated Contracts List with additional Designated Contracts or propose to modify any Cure Costs, the Debtors will promptly file and thereafter serve a supplemental notice (a "**Supplemental Notice of Assumption and Assignment**") to each affected counterparty at the last known address available to the Debtors in accordance with the Bidding Procedures Order.

PLEASE TAKE FURTHER NOTICE that the inclusion of a Designated Contract on the Designated Contracts List (or any supplement thereto) will not obligate the Debtors to assume any Designated Contract or the Successful Bidder(s) to take assignment of such Designated Contract. Only those Designated Contracts that are ultimately selected for assumption and assignment in accordance with any applicable Mexican Assets Sale Transaction will be assumed and assigned to the Successful Bidder(s).
