**DEBTORS' FOURTH MOTION FOR AN ORDER EXTENDING
THE PERIOD WITHIN WHICH THE DEBTORS MAY
REMOVE ACTIONS PURSUANT TO 28 U.S.C. § 1452**

Leisure Investments Holdings LLC and certain of its affiliates (collectively, the “**Debtors**”) in the above-captioned chapter 11 cases (collectively, the “**Chapter 11 Cases**”), hereby file this motion (this “**Motion**”) for entry of an order in the form attached hereto as **Exhibit A** (the “**Proposed Order**”), extending the period within which the Debtors may remove actions and related proceedings by approximately ninety (90) days, through and including June 29, 2026. In support of this Motion, the Debtors rely upon and incorporate by reference the *Declaration of Steven Robert Strom in Support of the Debtors' Chapter 11 Petitions and First Day Pleadings* [Docket No. 10] (the “**First Day Declaration**”).² In further support of this Motion, the Debtors respectfully state as follows:

JURISDICTION AND VENUE

1. The United States Bankruptcy Court for the District of Delaware (the “**Court**”) has jurisdiction to consider this Motion under 28 U.S.C. §§ 157 and 1334 and the *Amended Standing Order of Reference* from the United States District Court for the District of Delaware, dated as of February 29, 2012. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

2. This matter is a core proceeding pursuant to 28 U.S.C. § 157(b)(2), and, pursuant to rule 9013-1(f) of the Local Rules of the United States Bankruptcy Court for the District of Delaware (the “**Local Rules**”), the Debtors consent to the entry of a final order by the Court in connection with this Motion to the extent that it is later determined that the Court, absent the consent of the parties, cannot enter final orders or judgments consistent with Article III of the United States Constitution.

3. The statutory and legal predicates for the relief sought herein are rules 9006 and 9027 of the Federal Rules of Bankruptcy Procedure (the “**Bankruptcy Rules**”).

BACKGROUND

I. General Background

4. On March 31, 2025 (the “**Commencement Date**”), certain of the Debtors filed voluntary petitions for relief pursuant to chapter 11 of the Bankruptcy Code. On April 16, 2025 and May 4, 2025, affiliates Controladora Dolphín, S.A. de C.V. and Embassy of the Seas Limited, respectively, also filed voluntary petitions for relief pursuant to chapter 11 of the Bankruptcy Code. The Chapter 11 Cases are being jointly administered for procedural purposes only. *See* Docket Nos. 32, 68 & 126. The Debtors continue to operate their businesses and manage their properties as debtors in possession pursuant to sections 1107(a) and 1108 of the Bankruptcy Code.

5. On May 6, 2025, the Office of the United States Trustee for the District of Delaware (the “**U.S. Trustee**”) appointed an official committee of unsecured creditors (the “**Committee**”). *See* Docket Nos. 128 & 151.

6. Additional information regarding the Debtors, including their business operations, their corporate and capital structure, and the events leading to the commencement of the Chapter 11 Cases is set forth in detail in the First Day Declaration.

II. The Current Removal Deadline

7. On July 16, 2025, the Court entered the *Order Extending the Period Within Which the Debtors May Remove Actions Pursuant to 28 U.S.C. § 1453* [Docket No. 347], extending the time by which the Debtors may file notices of removal under 28 U.S.C. § 1452 from June 30, 2025 through and including September 29, 2025.

8. On October 15, 2025, the Court entered the *Order Extending the Period Within Which the Debtors May Remove Actions Pursuant to 28 U.S.C. § 1453* [Docket No. 591], extending the time by which the Debtors may file notices of removal under 28 U.S.C. § 1452 from September 29, 2025 through and including December 29, 2025.

9. On January 5, 2026, the Court entered the *Order Extending the Period Within Which the Debtors May Remove Actions Pursuant to 28 U.S.C. § 1452* [Docket No. 866] (the “**Third Extension Order**”), further extending the time by which the Debtors may file notices of removal under 28 U.S.C. § 1452 from December 29, 2025 through and including March 30, 2026.

RELIEF REQUESTED

10. The Debtors’ deadline to file notices removing actions and related proceedings, pursuant to 28 U.S.C. § 1452 and Bankruptcy Rule 9027, is currently March 30, 2026 (the “**Current Removal Deadline**”). By this Motion, the Debtors request that the Court enter the

Proposed Order extending the Current Removal Deadline by approximately ninety (90) days, through and including June 29, 2026,³ without prejudice to the rights of the Debtors and their estates to seek further extensions.⁴

BASIS FOR RELIEF

11. Section 1452 of title 28 of the United States Code and Bankruptcy Rule 9027 govern the removal of pending civil actions related to chapter 11 cases. Specifically, section 1452(a) provides that:

[a] party may remove any claim or cause of action in a civil action other than a proceeding before the United States Tax Court or a civil action by a governmental unit to enforce such governmental unit's police or regulatory power, to the district court for the district where such civil action is pending, if such district court has jurisdiction of such claim or cause of action under section 1334 of this title.

28 U.S.C. § 1452(a).

12. Bankruptcy Rule 9027 sets forth the time periods for filing notices to remove claims or causes of action. Specifically, Bankruptcy Rule 9027(a)(2) provides, in pertinent part, that:

[i]f the claim or cause of action in a civil action is pending when a case under the [Bankruptcy] Code is commenced, a notice of removal may be filed in the bankruptcy court only within the longest of (A) 90 days after the order for relief in the case under the Code, (B) 30 days after entry of an order terminating a stay, if the claim or cause of action in a civil action has been stayed under § 362 of the Code, or (C) 30 days after a trustee qualifies in a chapter 11 reorganization case but not later than 180 days after the order for relief.

Fed. R. Bankr. P. 9027(a)(2).

³ The ninety-day extension of the Current Removal Deadline falls on a Sunday. Pursuant to Bankruptcy Rule 9006(a), the Debtors are requesting that the deadline be continued to the following Monday, June 29, 2026.

⁴ Pursuant to Local Rule 9006-2, the filing of this Motion prior to the expiration of the Current Removal Deadline shall automatically extend the Current Removal Deadline until the Court acts on this Motion without the necessity for entry of a bridge order.

13. Bankruptcy Rule 9006(b) provides that the Court may extend unexpired time periods, such as the Debtors' removal period, without notice:

[W]hen an act is required or allowed to be done at or within a specified period by [the Bankruptcy Rules] or by a notice given thereunder or by order of court, the court for cause shown may at any time in its discretion ... with or without motion or notice order the period enlarged if the request therefor is made before the expiration of the period originally prescribed or as extended by a previous order.

Fed. R. Bankr. P. 9006(b)(1).

14. Accordingly, the Court is authorized to grant the relief requested herein. *See Pacor, Inc. v. Higgins*, 743 F.2d 984, n.17 (3d Cir. 1984), overruled on other grounds by *Things Remembered, Inc. v. Petrarca*, 516 U.S. 124, 134–35, 116 S. Ct. 494, 133 L.Ed.2d 461 (1995) (holding the bankruptcy court's power to grant an extension of the removal period pursuant to Bankruptcy Rule 9006(b) is "clear"); *Jandous Elec. Constr. Corp. v. City of New York (In re Jandous Elec. Constr. Corp.)*, 106 B.R. 48, 50 (Bankr. S.D.N.Y. 1989) (same); *Raff v. Gordon*, 58 B.R. 988, 990-91 (Bankr. E.D. Pa. 1986) (stating that the period in which to file a motion to remove may be expanded pursuant to Bankruptcy Rule 9006); *In re Boyer*, 108 B.R. 19, 26 (Bankr. N.D.N.Y. 1988) (same).

15. The Debtors may be parties to actions currently pending in other courts (collectively, the "**Actions**") and believe that it is prudent to seek an extension of the time established by Bankruptcy Rule 9027 to protect the rights of the Debtors and their estates to remove any such Actions.

16. The Debtors' professionals have worked diligently to progress the Chapter 11 Cases and to maximize the value of the Debtors' estates for the benefit of all stakeholders. Since the entry of the Third Extension Order, the Debtors have, among other things: (a) concluded the sale

and marketing process for certain of their assets in Florida, including the real property interests located in Duck Key, Florida (“**Dolphin Connection**”); (b) wound down their business operations at the Dolphin Connection facility and transferred the eight bottlenosed dolphins residing at Dolphin Connection (the “**Transferred Animals**”) to a third party; (c) engaged in the sale of Debtor Embassy of the Seas Limited’s shares of Zoomarine Italia SPA (the “**Zoomarine Italia Assets**”) and obtained approval thereof [Docket No. 975]; (d) continued their pursuit of substantial litigation efforts in Mexico to protect their assets; (e) continued to pursue a sale and marketing process for substantially all of their assets in Mexico and other geographies, and conducted negotiations with parties regarding the same; (f) negotiated with certain parties in interest regarding the terms of a chapter 11 plan and related disclosure statement; (g) responded to various creditor inquiries; and (h) handled various tasks related to the administration of the Debtors’ estates and the Chapter 11 Cases.

17. To adequately protect their interests, the Debtors require additional time to determine if any Actions should be removed pursuant to Bankruptcy Rule 9027(a). Accordingly, the Debtors submit that extending the Current Removal Deadline is in the best interests of the Debtors, their estates, and their creditors. The extension sought will afford the Debtors an opportunity to make more fully informed decisions concerning the removal of any Action and will assure that the Debtors and their estates do not forfeit the valuable rights afforded to them under 28 U.S.C. § 1452. Furthermore, the Debtors submit that granting the extension requested herein will not prejudice the rights of any other parties to the Actions because such parties may not prosecute them absent relief from the automatic stay. In addition, nothing herein will prejudice any party to an Action that the Debtors may ultimately attempt to remove from seeking the remand of such action under 28 U.S.C § 1452(b) at the appropriate time.

18. For the reasons set forth above, the Debtors submit that extending the Current Removal Deadline through and including June 29, 2026 is necessary, prudent, and in the best interests of the Debtors, their estates, and their creditors.

NOTICE

19. Notice of this Motion will be provided to: (a) the U.S. Trustee; (b) counsel to the Committee; (c) counsel to the Prepetition First Lien Noteholders and DIP Lenders; (d) counsel to the DIP Agent; (e) counsel to the Prepetition Second Lien Noteholders; (f) counsel to the Prepetition First Lien Collateral Agent and the Prepetition Second Lien Collateral Agent; (g) all non-Debtor parties to any of the Actions, or their counsel, if known; and (h) all parties that have filed a notice of appearance and request for service of papers pursuant to Bankruptcy Rule 2002. In light of the nature of the relief requested herein, the Debtors submit that no other or further notice is necessary.

circumstances, and it appearing that no other or further notice need be provided; and this Court having found that the relief requested herein is in the best interests of the Debtors and their estates; and upon the record herein; and after due deliberation and sufficient cause appearing therefor,

IT IS HEREBY ORDERED THAT:

1. The Motion is GRANTED as set forth herein.
2. The time period provided by Bankruptcy Rule 9027 within which the Debtors and their estates may file notices of removal of claims and causes of action is hereby extended through and including June 29, 2026 (the “**Removal Deadline**”).
3. Entry of this Order is without prejudice to the Debtors’ rights to seek further extensions of the Removal Deadline.
4. This Court retains jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
