This Amended Administrative Claim amends the *Administrative Expense Proof of Claim and Request for Payment of Administrative Expense* filed on July 12, 2023 (the "<u>Original Administrative Claim</u>") [Dkt. No. 1649]. The undersigned is duly authorized by KCC to file this Administrative Claim.

2. KCC is the Bankruptcy Court approved claims, noticing, and solicitation agent for the above-captioned Liquidating Debtors (the "<u>Debtors</u>") pursuant to the Order Granting Debtors' Application for Entry of an Order (A) Authorizing the Retention and Employment of Kurtzman Carson Consultants LLC as Claims, Noticing and Solicitation Agent, Nunc Pro Tunc to the Petition Date and (B) Granting Related Relief [Docket No. 110] (the "<u>KCC Order</u>").

3. For the period of March 1, 2023 through June 30, 2023, the Debtors were indebted to KCC in the sum of \$174,422.19 (the "<u>Original Administrative Claim Amount</u>") under the terms of the KCC Order and the Services Agreement (as such term is defined in the KCC Order). After filing the Original Administrative Claim, KCC received payment for the full amount of \$174,422.19 on August 28, 2023. KCC accordingly withdraws its Original Administrative Claim.

4. For the period of July 1, 2023 through July 31, 2023, the Debtors are indebted to KCC in the sum of \$25,459.55 (the "<u>Amended Administrative Claim Amount</u>"). The Amended Administrative Claim Amount is an administrative expense of each of the Debtors' estates pursuant to the terms of the KCC Order, 28 U.S.C. § 156(c) and 11 U.S.C. § 503(b)(1)(A). See attached Exhibit A for a listing of the outstanding invoice.
