Subject to the terms of this Retention Bonus Agreement you shall receive a retention bonus in the total amount of \$50,700.00 (the "Total Retention Award Amount"). The Company or its successor(s) shall pay you \$25,350.00, less taxes and ordinary payroll deductions and withholdings on January 2, 2024, and \$25,350.00, less taxes and ordinary payroll deductions and withholdings on June 14, 2024, provided that you remain employed by the Company or its successor(s) on the payments dates.
