PLEASE TAKE FURTHER NOTICE that on May 17, 2024, the Debtors filed with the Court the *Debtors’ Application for Entry of an Order Authorizing the Employment and Retention of Deloitte Tax LLP as Tax Services Provider Effective as of the Petition Date* [Docket No. 279] (the “Deloitte Retention Application”). Upon filing of a CNO, the Court may enter the order without further notice or hearing. As of the filing of this CNO, no responsive pleading to the Deloitte Retention Application has been (a) filed with the Court on the docket of the above-captioned chapter 11 cases, or (b) served on the Debtors or their counsel. Accordingly, the Debtors respectfully request entry of the proposed order granting the relief requested in the Deloitte Retention Application.
