Dear Judge Mastando:

We write on behalf of our clients: Apargo Limited, Fentalon Limited, and Desimusco Trading Limited (collectively, the “Preferred Shareholders”), the three Preferred Shareholders of Eletson Gas LLC. ECF 1586, 1587. We are aware of the multiple motions filed yesterday by Eletson Holdings, Inc. (“Motions”), as well as the letters filed today by Reed Smith (ECF 1610) and Rolnick Kramer Sadighi LLP (“RKS”). ECF 1611.

At this point, we do not believe that any of the Motions are directed at the Preferred Shareholders, but we continue our review of them. To allow sufficient time for that review, and in the event that we conclude that it is necessary for the Preferred Shareholders to respond to the Motions in any way, we join Reed Smith and RKS in requesting a reasonable adjournment of the time period to respond to the Motions.
