**THIRD NOTICE OF FILING AMENDED

**PLEASE TAKE NOTICE** that, on April 12, 2024, the United States Bankruptcy Court for the Eastern District of Virginia (the “**Court**”) entered the *Order (I) Authorizing the Debtors to Retain and Compensate Professionals Utilized in the Ordinary Course of Business and (II) Granting Related Relief* [Docket No. 318] (the “**OCP Order**”) authorizing the above-captioned debtors and debtors-in-possession (collectively, the “**Debtors**”) to, among other things, establish the procedures set forth in the *Motion of Debtors for Entry of an Order (I) Authorizing the Debtors to Retain and Compensate Professionals Utilized in the Ordinary Course of Business and (II) Granting Related Relief* (the “**Motion**”) to retain and compensate professionals utilized in the ordinary course of business (collectively, the “**OCPs**”).<sup>2</sup> Attached to the Motion as Exhibits B-1 and B-2 was a non-exclusive list of the Debtors’ OCPs (the “**OCP List**”).

**PLEASE TAKE FURTHER NOTICE** that, pursuant to the OCP Order, the Debtors are authorized to supplement the OCP List by filing an amended OCP List with the Court, and the Debtors have supplemented the OCP List on May 7, 2024 at Docket No. 465 and on May 17, 2024 at Docket No. 589.

The objecting party shall file any such objection and serve such objection upon the Notice Parties and the respective OCP on or before the Objection Deadline.

**PLEASE TAKE FURTHER NOTICE** that, if no objection is received by the Objection Deadline with respect to any particular OCP, then retention of the OCP shall be deemed approved by the Court without hearing or further order.
