**MOTION FOR ADMISSION TO PRACTICE,
PRO HAC VICE, UNDER LOCAL BANKRUPTCY RULE 2090-1(E)(3)**

Michael D. Mueller (the “Movant”), hereby moves (the “Motion”) the Court, pursuant to Rule 2090-1(E)(3) of the Local Rules of the United States Bankruptcy Court for the Eastern District of Virginia (the “Local Rules”), to enter an order, substantially in the form annexed hereto as **Exhibit A** (the “Order”), authorizing Dennis F. Dunne to appear *pro hac vice* in the above-captioned chapter 11 cases (collectively, the “Chapter 11 Cases”) and any related proceeding for the purpose of representing an ad hoc committee of holders of Enviva RWE claims (the “Ad Hoc Committee”). In support of this Motion, the Movant states as follows:

1. The Movant is a member in good standing of the Bar of the Commonwealth of Virginia, an attorney admitted to practice before the United States Bankruptcy Court for the Eastern District of Virginia, a partner in the law firm of Williams Mullen.

2. Mr. Dunne is a member in good standing of the Bar of the State of New York and is admitted to practice before the Supreme Court of the United States, the Court of Appeals for the First, Second, Third, Fifth, and Ninth Circuits, and the United States District Court for the Southern District of New York. There are no disciplinary proceedings pending against Mr. Dunne in any jurisdiction in which he is admitted to practice.

3. The Movant requests that this Court authorize Mr. Dunne to file pleadings, to appear and be heard at hearings, and to otherwise participate in the Chapter 11 Cases and all related proceedings.

4. Mr. Dunne understands that if he is admitted *pro hac vice* to practice before this Court, he will be subject to the disciplinary jurisdiction of this Court.

5. The Movant and his law firm will serve as counsel to the Ad Hoc Committee with Mr. Dunne and other members of Milbank LLP in the Chapter 11 Cases and all related proceedings.

6. A copy of Mr. Dunne's written application to qualify, as required by Local Bankruptcy Rule 2090-1(E)(3), is appended to this Motion as **Exhibit B** and is incorporated by reference into this Motion.

7. Notice of this Motion will be served on the Office of the United States Trustee for the Eastern District of Virginia and counsel for the Debtors through the CM/ECF system. Because of the administrative nature of the relief requested herein, the Movant submits that no other or further notice is required.
