ROCKWELL AUTOMATION INC.'S OBJECTION TO AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION OF ENVIVA INC. AND ITS DEBTOR AFFILIATES & DEBTORS' CURE NOTICES OF ASSUMED <u>EXECUTORY CONTRACTS</u>

Rockwell Automation Inc. ("Rockwell") hereby files this Objection (the "Objection") to the (i) Notice of Cure of Assumed Executory Contract or Unexpired Lease dated October 23, 2024; (ii) Notice of Filing of Plan Supplement for the Amended Joint Chapter 11 Plan of Reorganization² of Enviva Inc. and its Debtor Affiliates (collectively, the "Debtors") [Docket No. 1251]; (iii) Notice of Cure of Assumed Executory Contract or Unexpired Lease dated November 5, 2024; and (iv) Notice of Filing of First Amended Plan Supplement for the Amended Joint Chapter 11 Plan of Reorganization of Enviva Inc. and its Debtor Affiliates [Docket No. 1283] (collectively, the "Cure Notice"). In support of its Objection, Rockwell respectfully submits the following:

BACKGROUND

A. The Product Purchase Agreement

- 1. Rockwell and Debtor Enviva Pellets Epes, LLC ("<u>Enviva</u>"), an affiliated Debtor in these Chapter 11 Cases, are parties to a Product Purchase Agreement dated March 20, 2023 (the "<u>Agreement</u>").
- 2. Under the Agreement Enviva owed Rockwell a total of \$318,801.63 in unpaid invoices (the "Cure Amount"), as reflected below:

3. A copy of these invoices are attached as **Exhibit A**.

B. Proposed Assumption of the Product Purchase Agreement

- 4. On October 23, 2024, the Debtors filed their *Notice of Filing of Plan Supplement* for the Amended Joint Chapter 11 Plan of Reorganization of Enviva Inc. and Its Debtor Affiliates [Docket No. 1251] (the "Plan Supplement"). In the Plan Supplement, the Agreement is listed as an executory contract, with no cure amount, to be assumed by the Debtors. *See* Plan Supplement, at ECF pg. 51 of 123.
- 5. On November 5, 2024, the Debtors filed their *Notice of Filing of First Amended Plan Supplement for the Amended Joint Chapter 11 Plan of Reorganization of Enviva Inc. and Its Debtor Affiliates* [Docket No. 1283] (the "Amended Plan Supplement"). In the Amended Plan Supplement, the Agreement is listed as an executory contract, with no cure amount, to be assumed by the Debtors. *See* Amended Plan Supplement, at ECF pgs. 58 and 84 of 105.

OBJECTION

- 6. "An executory contract may not be assumed when the debtor is in default unless the debtor takes the remedial steps specified in section 365(b)(1)." *U.S.*, *Dep't of Air Force v. Carolina Parachute Corp.*, 907 F.2d 1469, 1475 (4th Cir. 1990).
- 7. Section 365(b)(1) of the Bankruptcy Code conditions the Debtors' assumption of the Agreement as follows:
 - (1) If there has been a default in an executory contract or unexpired lease of the debtor, the trustee may not assume such contract or lease unless, at the time of assumption of such contract or lease, the trustee—
 - (A) cures, or provides adequate assurance that the trustee will promptly cure, such default other than a default that is a breach of a provision relating to the satisfaction of any provision (other than a penalty rate or penalty provision) relating to a default arising from any failure to perform nonmonetary obligations under an unexpired lease of real property, if it is impossible for the trustee to cure such default by performing nonmonetary acts at and after the time of assumption, except that if such default arises from a failure to operate in accordance with a nonresidential real property lease, then such default shall be cured by performance at and after the time of assumption in accordance with such lease, and pecuniary losses resulting from such default shall be compensated in accordance with the provisions of this paragraph;
 - (B) compensates, or provides adequate assurance that the trustee will promptly compensate, a party other than the debtor to such contract or lease, for any actual pecuniary loss to such party resulting from such default; and
 - (C) provides adequate assurance of future performance under such contract or lease.
- 8. Further, "[w]hen a debtor in possession assumes an executory contract, it takes the 'contracts *cum onere*, that is, subject to existing burdens." *Carolina Parachute Corp.*, 907 F.2d at 1475 (quoting *In re Chicago, R.I. & Pac. R.R.*, 860 F.2d 267, 272 (7th Cir. 1988)). That is, "a debtor may not assume the favorable aspects of a contract . . . and reject the unfavorable aspects of the same contract." *Id.* (quoting *Lee v. Schweiker*, 739 F.2d 870, 876 (3d Cir. 1984)).
- 9. Accordingly, the Debtors are prohibited from assuming the Agreement unless the Debtors (a) pay Rockwell the Cure Amount that is due and owing in full, (b) assume the Agreement *cum onere*, and (c) satisfy all conditions set forth in the Agreement.

RESERVATION OF RIGHTS

10. Rockwell reserves all rights it may have under the Agreement and any applicable law, including without limitation, the right to supplement or amend this Objection to assert any additional amounts due and owing under the Agreement or to assert any further objection related to the proposed assumption of the Agreement.

WHEREFORE, Rockwell respectfully requests that this Court enter an order: (i) conditioning the Debtors' assumption of the Agreement upon the Debtors (a) paying Rockwell the Cure Amount that is due and owing in full, (b) assuming the Agreement *cum onere*, and (c) satisfying all conditions set forth in the Agreement; and (ii) granting Rockwell any and such other and further relief as the Court deems just and proper.
