CASE MANAGEMENT ORDER NO. 5

The Court, for cause, enters this Case Management Order.

It is hereby **ORDERED**:

1. Omnibus Hearing Dates. The Court will schedule the following omnibus hearing dates:

- Thursday, April 24, 2025, at 2:00 p.m.

- Thursday, May 15, 2025, at 2:00 p.m.

Additional omnibus hearing dates will be scheduled in due course.

2. Expedited Hearings. In addition to the omnibus hearing dates, any party in interest may move for an expedited hearing in compliance with Local Rule 9013-1(N).

3. Hybrid Hearings. All hearings in this case will be hybrid (in-person and remotely). Hearings will be held in Courtroom 1, 200 S. Washington St., Alexandria, VA 22314. A zoom link or other information for remote access will be made available in advance of each hearing date.

4. Presentation of Evidence. Notwithstanding that the Court will hold hybrid hearings, all evidence will be presented in Court. Witnesses must be present in Court, including



any witness whose testimony is proffered or submitted by declaration or affidavit. No party will be permitted to examine or cross-examine a witness remotely.

5. Exchange of Exhibits. The Court will expect parties who are adverse to each other to cooperate in the exchange of Exhibits in advance of any contested hearing. Unless cause is shown to excuse compliance, or unless otherwise ordered with respect to a particular matter, the Court will require that Exhibits be exchanged two business days in advance of any contested matter hearing.
