# DECLARATION OF CLAUDIA Z. SPRINGER IN SUPPORT OF AN ORDER OF CONTEMPT AGAINST DEFENDANTS VOIZZIT TECHNOLOGY PRIVATE LTD, VOIZZIT INFORMATION TECHNOLOGY LLC, VINAY RAVINDRA AND RAJENDRAN VELLAPALTH

I, Claudia Z. Springer, hereby declare under penalty of perjury that the following is true to the best of my knowledge, information, and belief:

1. I am the duly appointed chapter 11 trustee (the "<u>Trustee</u>") for the Debtors, Epic! Creations, Inc. ("<u>Epic</u>"), Neuron Fuel, Inc. ("<u>Neuron Fuel, Inc.</u>"), and Tangible Play, Inc. ("<u>Tangible Play</u>," with Epic and Neuron Fuel, together the "<u>Debtors</u>"). The statements in this Declaration are based on my personal knowledge and information supplied or verified by the

Trustee's professionals and my review of the Debtors' business records, bank records, and other relevant documents. If called as a witness, I could and would testify competently to the facts set forth herein.

2. I am also a principal in the Philadelphia office of Novo Advisors, LLC ("<u>Novo</u>"), a restructuring-focused consulting firm. Prior to joining Novo in 2021, I practiced bankruptcy law for more than forty (40) years, most recently as a partner at Reed Smith LLP and prior to that as an associate and then partner at Duane Morris LLP.

3. The Debtors are three formerly unaffiliated U.S.-based education technology companies that develop and distribute three separate lines of educational products. Between 2019 and 2021, each Debtor was acquired by Think & Learn Pvt. Ltd. d/b/a Byju's ("<u>T&L</u>"), an Indian corporation founded by Byju Raveendran in 2011 with a stated purpose of providing accessible education technology.

4. Debtor Epic owns and distributes the leading reading application for children at home, at school, and on the go. Through its eponymous application, which is used in over eighty percent (80%) of U.S. public elementary schools, Epic provides electronic books and other educational materials to students in kindergarten through eighth grade via a subscription-based service. Epic was founded in 2012 and was acquired by T&L in July 2021 for a purported purchase price of approximately \$500 million.

5. Debtor Tangible Play develops and sells a variety of educational gaming products, including its well-known Osmo line of products, which use a combination of physical and digital components to engage children in augmented reality-based educational games and experiences. Tangible Play was founded in 2013 and was acquired by T&L in January 2019 for a purported purchase price of approximately \$120 million.

6. Debtor Neuron Fuel operates a subscription-based educational platform known as Tynker that provides gamified coding lessons to children with over one hundred million registered users across the globe. Neuron Fuel was founded in 2012 and was acquired by T&L in September 2021 for a purported purchase price of approximately \$200 million.

7. Since my appointment on September 23, 2024, my professionals and I have been focused on stabilizing the Debtors' businesses. As part of those efforts, I instructed my financial advisors at Novo to reach out to the tech companies that I understood provided the services necessary for the Debtors' operations and where the Debtors' various internet platforms and services were available, including Google, Apple, Stripe, Cloudflare, Github, and others, to ensure that these entities would transfer all control over these accounts to me and those working with me. This step was particularly important for these Debtors because T&L and certain of the Debtors' now former employees were not cooperating with my efforts to perform my duties as trustee and I discovered that funds in the Debtors' accounts were being transferred to non-Debtor entities (including the Voizzit Defendants or certain of them) without my consent or knowledge. As a result of these contacts, I came to learn that Voizzit Technology Private Ltd, Voizzit Information Technology LLC, and Rajendran Vellapalath (collectively, the "Voizzit Defendants"), as well as Vinay Ravindra (who I also understand is BYJU's Chief Content Officer), were actively working with Byju Raveendran to take control of the on-line platforms, e-mail accounts, and programs that are crucial to the Debtors' operations.

8. Each time I learned of a new theft of estate property, I instructed my counsel to file the appropriate pleadings or motions necessary to unwind the taking of estate assets and to obtain appropriate relief. To date, my counsel has been required to file three (3) different adversary proceedings and related emergency TRO motions with respect to the Debtors' Stripe account (Adv.

No. 24-50123), Google accounts (Adv. No. 24-50233), and the Voizzit Defendants' Indian complaint against the Trustee (Adv. No. 24-50280), two emergency motions to enforce the automatic stay with respect to the Debtors' Apple and Cloudflare accounts (D.I. 244; D.I. 340), and the pending contempt motion (Adv. No. 24-50233, D.I. 18). My counsel was also forced to separately negotiate consent orders providing for the turnover of the Debtors' Apple accounts (D.I. 230), Google accounts (D.I. 239), Cloudflare accounts (D.I. 311), and GoDaddy accounts (D.I. 328).

9. As it relates to these proceedings, on November 18, 2024, I authorized my counsel to file suit against Google, LLC, and the Voizzit Defendants, seeking among other relief, a temporary restraining order and preliminary and permanent injunction enjoining the Voizzit Defendants from continuing to exercise control over the Debtors' Google Workspace, Google Cloud, and Google Play Store accounts. I also sought relief against Google ordering it to return these accounts to the Debtors and my control.

10. The Voizzit Defendants theft of the Debtors' Google accounts was particularly problematic because these accounts host the Debtors' corporate records, emails, data, and software codes, including a code that directs the payments from the Debtors' websites and applications to various payment processors. Thus, by virtue of their control over the software code contained in the Debtors' Google Cloud accounts, the Voizzit Defendants would have had the ability to redirect payments made through the Debtors' websites to different payment processor accounts beyond the Trustee's reach (which I believe the Voizzit Defendants or certain of them in fact did).

11. On November 19, 2024, the Court entered its *Order Granting Chapter 11 Trustee's Motion For A Temporary Injunction* [Adv. D.I. 15] (the "<u>TRO</u>"), granting the relief I sought and

directing the Voizzit Defendants to take certain actions by November 22, 2024. Specifically,

paragraph 3 of the TRO directed that:

On or before 5:00 p.m. E.T. on November 22, 2024, Defendants Voizzit Technology Private Ltd, Voizzit Information Technology LLC, Vinay Ravindra, and Rajendran Vellapalath (the "Voizzit Defendants") shall provide the Trustee and Google with a complete list of all accounts, assets, email extensions, projects, entity names, or other credentials relating in any way to the Google Accounts that were transferred by or to one or more of the Voizzit Defendants or individuals or entities working in concert with them from June 4, 2024 to present, and shall facilitate the transfer of any such email extensions, projects, entity names, or other credentials relations, projects, entity names, or other credentials from the Voizzit Defendants or individuals or entities under their control and to the Trustee.

(TRO,  $\P$  3.) Paragraph 5 of the TRO directed that:

Defendant Voizzit Information Technology LLC is directed to transfer to the Trustee at instructions provided by the Trustee the Debtors' applications, data, project, funds, or any other information or property of the Debtors; given that any such transfer to Voizzit Information Technology LLC was void *ab initio* and a legal nullity, such that the technical return transfer to the Trustee maintains the status quo.

(TRO, ¶ 5.)

12. The Voizzit Defendants did not comply with the terms of the TRO.

13. On November 26, 2024, I directed my counsel to file the Chapter 11 Trustee's

Emergency Motion for Contempt to Hold the Voizzit Defendants in Contempt of Court for their

Failure to Comply with the Court's November 19 Order. [Adv. D.I. 18 (the "Contempt Motion").]

14. On December 3, 2024, the Court held a hearing on both the Contempt Motion and

the Trustee's Motion for a Preliminary Injunction. The Court granted both motions. Like the TRO,

the Court's Order Granting Chapter 11 Trustee's Motion for Preliminary Injunction directed the

Voizzit Defendants to take certain actions in connection with the Debtors' Google accounts. [Adv.

D.I. 36 (the "PI")] Specifically, paragraph 3 of the PI directed that:

Defendants Voizzit Technology Private Ltd, Voizzit Information Technology LLC, Vinay Ravindra, and Rajendran Vellapalath (the "Voizzit Defendants") shall

provide the Trustee and Google with a complete list of all accounts, assets, email extensions, projects, entity names, or other credentials relating in any way to the Google Accounts that were transferred by or to one or more of the Voizzit Defendants or individuals or entities working in concert with them from June 4, 2024 to present, and shall facilitate the transfer of any such email extensions, projects, entity names, or other credentials from the Voizzit Defendants or individuals or entities under their control and to the Trustee.

(PI,  $\P$  3.) Paragraph 5 of the PI directed that:

Defendant Voizzit Information Technology LLC is directed to transfer to the Trustee at instructions provided by the Trustee the Debtors' applications, data, project, funds, or any other information or property of the Debtors; given that any such transfer to Voizzit Information Technology LLC was void *ab initio* and a legal nullity, such that the technical return transfer to the Trustee maintains the status quo.

(PI, ¶ 5.)

15. On December 4, 2024, the Court also entered an *Order to Show Cause* why the Voizzit Defendants should not be held in contempt of the Court for their failure to comply with the TRO. [Adv. D.I. 39.] The show cause hearing is scheduled for January 22, 2024 at 10:00 a.m. The Voizzit Defendants were ordered to appear in person and the Court ruled that it would consider "all possible sanctions against the Voizzit Defendants, including imposition of a daily fine and/or placing Defendants Ravindra Vinay or Rajendran Vellapalath in civil confinement until they purge the Voizzit Defendants of such contempt." [*Id.*]

16. To date, the Voizzit Defendants have not complied with the terms of the TRO or the PI, and they continue to interfere with my efforts as Trustee to operate the Debtors' businesses so as to maximize value for creditors. Specifically, the Voizzit Defendants have violated both the TRO and PI in each of the following ways:

(a) *First*, the Voizzit Defendants have never provided me with "a complete list of all accounts, assets, email extensions, projects, entity names, or other credentials relating in any way to the Google Accounts that were transferred by or to one or more of the Voizzit

Defendants or individuals or entities working in concert with them from June 4, 2024 to present." (TRO, ¶ 3; PI, ¶ 3.) The failure to provide this information was and continues to be problematic. At the outset, Google informed my counsel that, to quickly transfer the accounts back to the Debtors, the Voizzit Defendants would need to make these identifications for Google and then would need to cooperate in moving the accounts back to the Debtors' control. A true and correct copy of an email which my counsel and I received on or about November 20, 2024 from Google's counsel explaining this issue is attached hereto as Exhibit 1. The Voizzit Defendants' failure to comply with this Court's TRO and PI delayed the transfer of the accounts back to the Debtors' estates by several days and caused increased expense on the part of my counsel and my financial advisors as they were forced to work through the issues with Google.

(b) Second, while Google ultimately was able to transfer the known accounts back to the Debtors and those accounts are now under my control, I have no way of knowing whether all accounts and associated projects were transferred back to the Trustee's control. Based on the extensive efforts taken, I believe that we have recovered all of the accounts, but it is impossible to know if that is the case without the Voizzit Defendants confirming what they took from the Debtors. My concern about obtaining this list is amplified based on the extensive misconduct that has been uncovered in these bankruptcy cases; and on the fact that, on December 4 and 5, 2024, after I obtained access to and control over the Google accounts, I received emails from a legal@Voizzit.com address and signed by "Sai" advising that \$1,067,000 was owed to Google and, if not paid, Google would suspend the accounts. When I caused my counsel to ask Google if this was true, Google asked for the email address of the Google contact that threatened suspension of the account. In turn, on December 5, 2024, Jacob Grall posed that same question to legal@Voizzit.com. As of the

date of this declaration, Voizzit's Legal Department has not responded. A true and correct copy of an email chain between my counsel and Google's counsel on this issue and the original email from legal@voizzit.com is attached hereto as <u>Exhibit 2</u>. Assuming Voizzit's Legal Department's email to me was truthful (and not simply an attempt by the Voizzit Defendants to create confusion), it suggests that there is at least information available to, and potentially also accounts still linked to, the Voizzit Defendants related to the Debtors that have not been turned over.

Third, Defendant Voizzit Information Technology LLC was twice ordered "to (c)transfer all of the Debtors' applications, data, project, funds, or any other information or property of the Debtors" to the Trustee. (TRO, ¶ 5; PI, ¶ 5.) Voizzit Information Technology LLC did not do that. Once I obtained control over the Google accounts, I discovered that there was no data about account activity during the two months that those accounts were under the Voizzit Defendants' control, namely from on or around September 26, 2024 through November 26, 2024, the date on which I, as the Chapter 11 Trustee was able to obtain control over the Google accounts. Typically the accounts would have data showing the length of time a user accessed the platform and what content they viewed. This data informs, among other decisions, the calculation of amounts due to publishers on a quarterly basis. None of that usage data was in the accounts when I regained control of the accounts. When I asked Google for that data, Google's counsel advised that its customers manage their own data and that, while such data might have existed in the accounts at one time, Google could not reproduce the data if it was no longer in the account. A true and correct copy of an email exchange with Google's counsel about this issue is attached hereto as Exhibit 3. Now that I have control of the Google accounts, this data is available for the current operations of the account. It therefore appears that during the time

it took Google to transfer control over the accounts—a time period delayed by the Voizzit Defendants' failure to comply with the TRO—the Voizzit Defendants stripped the accounts of data generated during the period they controlled the accounts. This will create issues for the estate in determining what amounts are owed to content creators for the use of their works during the third quarter of 2024.

(d) *Fourth*, the Voizzit Defendants told this Court at a prior hearing that they were actively maintaining the Debtors' Google accounts while they were under the Voizzit Defendants' control. This is not true. When I regained control over the Google accounts, the Chief Technical Officer for the Debtors discovered that the Voizzit Defendants had not maintained the accounts and instead had inserted code into the programs and taken other actions that harmed the programs. He was able to fix these issues, but this wrongful conduct has harmed the estate by diverting resources to fix a problem that never should have occurred in the first place.

(e) *Fifth*, the Voizzit Defendants have not accounted for any funds received while they were in control of the Debtors' Google accounts in violation of both the TRO and the PI.<sup>2</sup>

(f) *Sixth*, as a result of the Voizzit Defendants interference with the Debtors' Google accounts and the other wrongful actions they have taken, I have had to repeatedly negotiate with the Debtors' secured creditors for extensions of the milestones contained in the loan agreements. My counsel has sought and obtained five extensions of the deadline to file the bidding procedures motion. I initially agreed to start the sale process on November 15, 2024 with sales closing by December 30, 2024 for the Epic assets and January 31, 2025,

for the Tangible Play and Neuron Fuel assets. As a result of the Voizzit Defendants actions, instead of launching a sale process in November 2024, the sale process is now just starting and any sales will likely not close until April 2025.

Seventh and finally, contrary to the TRO, which required the Voizzit Defendants to (g) relinquish control over the Google accounts, the Voizzit Defendants did the exact opposite by filing suit on November 20, 2024, in India against the Trustee, Google India Pvt. Ltd., and other internet companies asking the Indian court to bar the Trustee from interfering with the Voizzit Defendants' access to, among other platforms, the Google accounts. This action was in direct violation of paragraph 4 of the TRO, which enjoined the Voizzit Defendants from "exercising ownership over . . . property of the Estates" and from "taking actions to impair in any way . . . property of the Estates...". By filing a lawsuit claiming ownership over the Debtors' property, including the Google accounts, the Voizzit Defendants have succeeded in creating confusion about who is entitled to operate the Debtors' businesses. This is occurring at the same time as the Trustee is engaged in a sales process for the Debtors, something that William Hailer during a hearing on November 21, 2024, that the Voizzit Defendants intended to do.<sup>3</sup> To remedy this violation of the TRO and PI, I filed a lawsuit seeking a temporary restraining order and preliminary injunction directing the Voizzit Defendants to dismiss the India lawsuit. This Court ordered the Voizzit Defendants to dismiss the Indian suit. Once those orders were entered, I directed my counsel in India to send the letter attached hereto as Exhibit 4 to the Voizzit Defendants'

counsel in India, asking that their clients withdraw the lawsuit. To date, the Voizzit Defendants have not withdrawn their lawsuit. As a result, my counsel in India has and will continue to incur additional fees enforcing this Court's orders in India.

17. Additionally, the estate has incurred substantial legal and other professional fees as a result of the Voizzit Defendants' failure to comply with the TRO and PI, as set forth in the statements attached as Group Exhibit 5 and summarized below:

In addition, my counsel will incur additional fees attending the contempt hearing.

18. For all of these reasons, I am asking the Court to hold the Voizzit Defendants in civil contempt and to award the following relief to compel compliance with its TRO (the obligations of which were also memorialized in the Court's PI) and to compensate the estate for the damages caused by the Voizzit Defendants failure to comply with this Court's Orders:

(a) A daily fine in an amount determined by the Court to be appropriate and an order of confinement against the individual Defendants to remain in place until the Voizzit Defendants, at a minimum, fully comply with paragraphs 3 and 5 of the TRO, including specifically (i) providing the information required by paragraph 3 of the TRO, (ii) producing the data they stripped from the Debtors' accounts while they were in control of those accounts, and (iii) accounting for and returning any funds received while they were in control of the Debtors' Google accounts. Furthermore, the Court should (iv) require the Voizzit Defendants, as a further condition of their compliance, to dismiss their Indian lawsuit.

(b) Damages equal to the legal and other professional fees incurred in enforcing the TRO.
