FINAL UPDATED RESPONSE AND OBJECTION TO LIQUIDATING TRUSTEE'S TWELFTH OMNIBUS OBJECTION TO CERTAIN MISCLASSIFIED CLAIMS

- 1. My claim is based on the actual payment made for a vehicle purchased from Fisker (see Exhibit A and Exhibit B).
- 2. While the Debtor delivered a vehicle, the delivered product was defective, unusable, and essentially worthless (see Exhibits D and E).
- 3. I repeatedly demanded that the Debtor take the vehicle back, but Fisker intentionally refused to do so (see Exhibit D).
- 4. Because the Debtor failed to provide a proper product and then refused to cure by retrieving the defective vehicle, the obligation remains unsatisfied. The defective vehicle is still in my possession and serves as collateral until full repayment.
- 5. On these grounds any of which independently justify relief my claim must be preserved as a secured claim in the amount originally filed and not reclassified.
- 6. I never signed any financial documents with the Debtor. Fisker took my payment for the vehicle, but I have no financial obligations toward the company. There is no contract binding me to any financial liability. Further, Fisker does not possess a signed Odometer Disclosure Statement or any other executed documents from me.
- 7. While I currently hold payment proofs totaling \$15,250 (deposits of \$250, \$5,000, and \$10,000), my total claim of \$35,000 is fully justified. The balance represents direct and consequential damages, including:
- 8. the total loss of value and utility of the defective vehicle;
- 9. insurance premiums I was forced to pay for a car that could not be registered;
- 10. out-of-pocket repair expenses with independent specialists;
- 11. the time, stress, and loss of use caused by Fisker's misconduct;
- 12. and additionally, before Fisker promised to deliver the vehicle, I sold my previous car at a significant loss in reliance on receiving a new replacement vehicle, but instead was left with a defective and unusable car.
- 13. Fisker never provided me with a valid Purchase Agreement, financial documents, or a signed Odometer Disclosure Statement. After realizing their error, they attempted to persuade me to sign documents retroactively, but I refused.
- 14. Because Fisker failed to provide registration documents, the vehicle remains unregistered and unusable. I was unable to legally operate it for more than 90 days. Despite my repeated written requests, Fisker provided no assistance or remedy.
- 15. I hold no financial obligations toward Fisker. My payments consisted only of the three deposits noted above. Fisker delivered the vehicle but never provided me with a financing contract or a valid

purchase agreement.

- 16. After Chase ceased financing Fisker vehicles, Fisker attempted to pressure me into financing directly with them, allegedly at 1%. I refused after discovering that the delivered vehicle was defective and in extremely poor condition.
- 17. I demanded that Fisker take the vehicle back, but they refused. Moreover, there were repeated attempts to deceive me: I received calls from unknown individuals offering to remove the vehicle, but refusing to return the money I had paid. I declined such terms, realizing that this was simply an attempt to mislead me and act solely in Fisker's favor rather than fairly resolve the matter.
- 18. The vehicle presented numerous defects: the air conditioning was completely inoperative; the tires were dangerously worn within a short period; and there were multiple mechanical and electronic failures.
- 19. For these reasons, my actions have been justified, my claim of \$35,000 is fully substantiated, and Fisker's misconduct demonstrates why my claim must be preserved in full and recognized as secured.
