- 2. Responses, if any, to the Claim Objection were to be filed and served upon counsel for the Liquidating Trustee no later than 4:00 p.m. (ET) on December 22, 2025 (the "**Response Deadline**").
- 3. Prior to the Response Deadline, the Liquidating Trustee received (a) formal responses from (i) Lucas Swingley [Docket No. 1198] (Claim No. 1973); (ii) Tyson Brown [Docket No. 1199] (Claim No. 1219); (iii) Dennis Wong [Docket No. 1203] (Claim No. 1513); (iv) Mhisani Miller [Docket No. 1204] (Claim No. 1925); and (v) Hesham Sharawy [Docket No. 1205] (Claim No. 3571); and (b) an informal response from Greg Moyer (Claim No. 3211) (collectively, the "**Objectors**").
- 4. The Liquidating Trustee has agreed to adjourn the Claim Objection as to the proofs of claim filed by the Objectors (collectively, the "<u>Adjourned Claims</u>") to a date and time to be determined.
- 5. Accordingly, attached hereto as **Exhibit 1** is a revised proposed form of order (the "**Revised Proposed Order**") that omits the Adjourned Claims from <u>Schedule 1</u>.
- 6. A redline comparing the Proposed Order against the Revised Proposed Order is attached hereto as **Exhibit 2**.
- 7. Other than as set forth herein, the Liquidating Trustee has not received any other responses or other informal comments to the Claim Objection or Proposed Order.
- 8. The Liquidating Trustee respectfully requests that the Court enter the Revised Proposed Order at its earliest convenience.

other notice need be given; and the Court having considered the Objection, the No Liability Claims listed on **Schedule 1** hereto, and any responses thereto; and upon the record herein; and, after due deliberation and sufficient cause appearing therefore, it is FOUND AND DETERMINED that:

- A. This Objection is a core proceeding under 28 U.S.C. § 157(b)(2).
- B. Each holder of a No Liability Claim listed on <u>Schedule 1</u> attached hereto was properly and timely served with a copy of the Objection, the Wright Declaration, this Order, the accompanying schedule of No Liability Claims, and the notice of Objection.
- C. Any entity known to have an interest in the No Liability Claims subject to the Objection has been afforded reasonable opportunity to respond to, or be heard regarding, the relief requested in the Objection.
- D. The relief requested in the Objection is in the best interests of the Debtors' creditors, the Debtors' estates, the Liquidating Trust and other parties-in-interest; and it is therefore:

#### ORDERED that:

- 1. The Objection is GRANTED as set forth herein.
- 2. Any response to the Objection not otherwise withdrawn, resolved, or adjourned is hereby overruled on its merits.
- 3. Each of the No Liability Claims listed on **Schedule 1** hereto is hereby disallowed in full and expunged for all purposes.
- 4. The Liquidating Trustee's rights to further object at a later date and on any basis to the No Liability Claims, if necessary, are fully preserved.
- 5. The official claims register in these Chapter 11 Cases shall be modified in accordance with this Order.

- 6. The Liquidating Trustee's rights and the rights of other parties-in-interest to file additional objections to the No Liability Claims or any other Claims (filed or not) which may be asserted against the Debtors and/or the Liquidating Trust, are fully preserved. Additionally, should one or more of the grounds of objection stated in the Objection be dismissed, the Liquidating Trustee's rights and the rights of other parties-in interest to object on other stated grounds or on any other grounds that the Liquidating Trustee or other parties-in-interest may discover are further preserved.
- 7. Notwithstanding the possible applicability of Bankruptcy Rules 6004, 7062, 9014 or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry. All time periods set forth in the Order shall be calculated in accordance with Bankruptcy Rule 9006(a).
- 8. This Court shall retain jurisdiction over the Liquidating Trustee and the claimants whose Claims are subject to the Objection with respect to any matters related to or arising from the Objection and the implementation of this Order.

- A. This Objection is a core proceeding under 28 U.S.C. § 157(b)(2).
- B. Each holder of a No Liability Claim listed on <u>Schedule 1</u> attached hereto was properly and timely served with a copy of the Objection, the Wright Declaration, this Order, the accompanying schedule of No Liability Claims, and the notice of Objection.
- C. Any entity known to have an interest in the No Liability Claims subject to the Objection has been afforded reasonable opportunity to respond to, or be heard regarding, the relief requested in the Objection.
- D. The relief requested in the Objection is in the best interests of the Debtors' creditors, the Debtors' estates, the Liquidating Trust and other parties-in-interest; and it is therefore:

#### ORDERED that:

- 1. The Objection is GRANTED as set forth herein.
- 2. Any response to the Objection not otherwise withdrawn, resolved, or adjourned is hereby overruled on its merits.
- 3. Each of the No Liability Claims listed on **Schedule 1** hereto is hereby disallowed in full and expunged for all purposes.
- 4. The Liquidating Trustee's rights to further object at a later date and on any basis to the No Liability Claims, if necessary, are fully preserved.
- 5. The official claims register in these Chapter 11 Cases shall be modified in accordance with this Order.

- 6. The Liquidating Trustee's rights and the rights of other parties-in-interest to file additional objections to the No Liability Claims or any other Claims (filed or not) which may be asserted against the Debtors and/or the Liquidating Trust, are fully preserved. Additionally, should one or more of the grounds of objection stated in the Objection be dismissed, the Liquidating Trustee's rights and the rights of other parties-in interest to object on other stated grounds or on any other grounds that the Liquidating Trustee or other parties-in-interest may discover are further preserved.
- 7. Notwithstanding the possible applicability of Bankruptcy Rules 6004, 7062, 9014 or otherwise, the terms and conditions of this Order shall be immediately effective and enforceable upon its entry. All time periods set forth in the Order shall be calculated in accordance with Bankruptcy Rule 9006(a).
- 8. This Court shall retain jurisdiction over the Liquidating Trustee and the claimants whose Claims are subject to the Objection with respect to any matters related to or arising from the Objection and the implementation of this Order.
