DECLARATION OF P. JOSEPH MORROW IV WITH RESPECT TO THE TABULATION OF VOTES ON THE DEBTORS' JOINT PLAN PURSUANT TO CHAPTER 11 OF THE BANKRUPTCY CODE

I, P. Joseph Morrow IV, depose and say under the penalty of perjury:

- 1. I am a Vice President of Corporate Restructuring Services, employed by Kurtzman Carson Consultants, LLC doing business as Verita Global LLC ("Verita"), whose main business address is 222 North Pacific Coast Highway, 3rd Floor, El Segundo, California 90245. I am above eighteen years of age, and I am competent to testify. Except as otherwise noted, all facts set forth herein are based on my personal knowledge, knowledge that I acquired from individuals under my supervision, and my review of relevant documents. I am authorized to submit this declaration (the "Declaration") on behalf of Verita. If I were called to testify, I could and would testify competently as to the facts set forth herein.
- 2. I submit this Declaration regarding the solicitation of votes and the tabulation of Ballots cast on the *Debtors' Joint Plan Pursuant to Chapter 11 of the Bankruptcy Code* [Docket No. 343] (as may amended, modified, or supplemented from time to time, the "**Plan**").

The Debtors in these cases, along with the last four digits of each Debtor's federal tax identification number, are: F21 OpCo, LLC (8773); F21 Puerto Rico, LLC (5906); and F21 GiftCo Management, LLC (6412). The Debtors' address for purposes of service in these Chapter 11 Cases is 110 East 9th Street, Suite A500, Los Angeles, CA 90079.



- 3. The Court authorized Verita's retention (a) as claims and noticing agent to the Debtors on March 18, 2025, pursuant to the Order Appointing Kurtzman Carson Consultants, LLC dba Verita Global as Claims and Noticing Agent Effective as of the Petition Date [Docket No. 72], and (b) as administrative advisor to the Debtors on April 11, 2025, pursuant to the Order Authorizing the Debtors to Retain Kurtzman Carson Consultants, LLC dba Verita Global as Administrative Advisor to the Debtors and Debtors in Possession, Effective as of the Petition Date [Docket No. 189] (together, the "Retention Orders"). The Retention Orders authorize Verita to assist the Debtors with, among other things, the service of solicitation materials and tabulation of votes cast to accept or reject the Plan. Verita and its employees have considerable experience in soliciting and tabulating votes to accept or reject chapter 11 plans.
- 4. On May 12, 2025, the Court entered the *Order (I) Approving (A) the Adequacy of the Disclosure Statement; (B) the Solicitation and Notice Procedures with Respect to Confirmation of the Debtors' Joint Chapter 11 Plan; and (C) the Forms of Ballots and Notices in Connection Therewith; (II) Scheduling Certain Dates with Respect Thereto; and (III) Granting Related Relief [Docket No. 335] (the "Disclosure Statement Order"),* establishing, among other things, the Solicitation and Voting Procedures. Verita adhered to the procedures outlined in the Disclosure Statement Order and caused the Ballots to be distributed to parties entitled to vote on the Plan. I supervised the solicitation and tabulation performed by Verita's employees.

A. Service and Transmittal of Solicitation Packages and Related Information

5. Pursuant to the Disclosure Statement Order, on May 19, 2025, and from time to time thereafter, Verita caused the Solicitation Packages to be served on all known Holders of Claims in Class 3 (ABL Claims), Class 4 (Term Loan Claims), Class 5 (Subordinated Loan Claims), and Class

6 (General Unsecured Claims) (collectively, the "Voting Classes"). In lieu of a Solicitation Package, all known Holders of Claims and Interests in Class 1 (Other Secured Claims), Class 2 (Other Priority Claims), and Class 9 (Existing Equity Interests) (collectively, the "Non-Voting Classes") received a Non-Voting Status Notice.³ Furthermore, Verita caused the *Notice of Hearing to Consider Confirmation of the Debtors' Chapter 11 Plan and Related Voting and Objection Deadlines* [Docket No. 345] (the "Confirmation Hearing Notice") to be served on the creditor matrix and all other parties required to receive such notice pursuant to the Disclosure Statement Order. A *Certificate of Service* evidencing the completion of solicitation was filed with the Court on May 28, 2025 [Docket No. 399].

- 6. On May 19, 2025, Verita posted links to the electronic versions of the Disclosure Statement Order, Plan, Disclosure Statement, and the Combined Hearing Notice on the public access website at www.veritaglobal.net/forever21.
- 7. The Confirmation Hearing Notice was published as follows: on May 19, 2025 in *The New York Times* (national edition); on May 20, 2025 in *The Los Angeles Times*; and on May 21, 2025 in *South China Morning Post*. The *Affidavit of Publication* evidencing the publication of the Confirmation Hearing Notice was filed with the Court on June 3, 2025 [Docket No. 412].
- 8. Verita also forwarded Solicitation Packages and Confirmation Hearing Notices to voting and creditor matrix parties, as applicable, whose packages were returned with a forwarding address or if an alternate address was available. The supplemental certificate of service evidencing the foregoing was filed with the Court on June 14, 2025 [Docket No. 456] (together with the certificate of service filed on May 28, 2025 the "Solicitation Certificates").

Pursuant to paragraph 20 of the Disclosure Statement Order, the Debtors were not required to provide Class 7 (Intercompany Claims) and Class 8 (Intercompany Interests) with a Solicitation Package or any other type of notice in connection with solicitation or Plan confirmation.

B. The Tabulation Process

- 9. The Disclosure Statement Order established May 12, 2024, as the Voting Record Date to determine which Holders of Claims and Interests were entitled to receive the Solicitation Package or the Non-Voting Status Notice, as applicable. Pursuant to the Disclosure Statement Order, Holders of Claims in Class 3 (ABL Claims), Class 4 (Term Loan Claims), Class 5 (Subordinated Loan Claims), and Class 6 (General Unsecured Claims) were entitled to vote to accept or reject the Plan. No other Classes were entitled or permitted to vote on the Plan.
- 10. In accordance with the Solicitation and Voting Procedures, Verita worked closely with the Debtors' advisors to identify the Holders of Claims in the Voting Classes entitled to vote as of the Voting Record Date, and to coordinate the distribution of Solicitation Packages to such Holders. A detailed description of Verita's distribution of Solicitation Packages is set forth in the Solicitation Certificates.
- 11. Pursuant to the Disclosure Statement Order, Verita relied on the Debtors' Schedules of Assets and Liabilities and the Claims information reflected in Verita's CaseView⁴ system to identify and solicit Holders of Claims in the Voting Classes. Additionally, for Class 3 (ABL Claims), Class 4 (Term Loan Claims), and Class 5 (Subordinated Loan Claims), Verita relied on the lender registers from the ABL Agent, Term Loan Agent and Subordinated Loan Agent, respectively.
- 12. In accordance with the Solicitation and Voting Procedures, Verita received, reviewed, determined the validity of, and tabulated the Ballots submitted to vote on the Plan. Each Ballot submitted to Verita was date-stamped, scanned, assigned a Ballot number, entered into Verita's voting database, and processed. To be included in the tabulation results as valid, a Ballot must have been (a) properly completed pursuant to the Solicitation and Voting Procedures, (b) executed by the

relevant Holder entitled to vote on the Plan (or such Holder's representative), (c) returned to Verita via an approved method of delivery set forth in the Solicitation and Voting Procedures unless the delivery method requirement was waived by the Debtors, and (d) received by Verita on or before June 16, 2025, at 4:00 p.m. (prevailing Eastern Time) (the "Voting Deadline"). Additionally, the Solicitation and Voting Procedures permit the Debtors to accept Ballots received after the Voting Deadline in the Debtors' sole discretion, and in accordance therewith, the Debtors have also allowed and tabulated the Ballots received after the Voting Deadline so long as they were received by June 16, 2025 at 11:59 p.m. (prevailing Eastern Time) (the "Late-Filed Deadline"). Accordingly, all Ballots cast by Holders entitled to vote in the Voting Classes and received by Verita on or before the Voting Deadline or the Late-Filed Deadline were tabulated pursuant to the Solicitation and Voting Procedures. Verita completed its final tabulation of the Ballots on June 17, 2025, following a complete review and audit of all Ballots received.

13. The final tabulation of votes cast by timely and properly completed Ballots received by Verita is attached hereto as **Exhibit A** (the "**Final Ballot Tabulation**"). The detailed Ballot reports for the Class 3 (ABL Claims), Class 4 (Term Loan Claims), Class 5 (Subordinated Loan Claims), and Class 6 (General Unsecured Claims) are attached to this Declaration as **Exhibit A-1** through **Exhibit A-4**, respectively.

C. Ballots That Were Not Counted

14. A report of any Ballots from parties in the Voting Classes excluded from the Final Ballot Tabulation, and the reasons for exclusion of such Ballots, is attached hereto as **Exhibit B**. All such Ballots were not counted because they did not satisfy the requirements for a valid Ballot set forth in the Disclosure Statement Order.

D. Opt In Election

15. Verita also reviewed and documented elections recorded on the Ballots from Holders

of Claims in the Voting Classes that checked the box on such Ballot to opt into the Third-Party

Releases. A report of all Entities who opted into the Third-Party Releases by checking the opt in box

on their Ballot is attached hereto as **Exhibit C**. For the avoidance of doubt, this Declaration does not

certify the validity or enforceability of any opt-in elections received, including those reported on

Exhibit C, but rather is providing these opt-in election results for reporting and informational

purposes only.

E. Conclusion

16. To the best of my knowledge, information and belief, the foregoing information

concerning the distribution, submission, and tabulation of Ballots in connection with the Plan is true.
