**GLOBAL NOTES TO MONTHLY OPERATING  
REPORT FOR DEBTOR FULCRUM SIERRA HOLDINGS, LLC**

On September 9, 2024, the above-captioned debtors and debtors in possession (collectively, the “Debtors”) each commenced a voluntary case (collectively, these “Chapter 11 Cases”) under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101–1532 in the United States Bankruptcy Court for the District of Delaware (the “Bankruptcy Court”).

The following notes and statements of limitations and disclaimers should be referred to, and referenced in connection with, any review of the Monthly Operating Report (the “MOR”) for debtor Fulcrum Sierra Holdings, LLC.

**Introduction:**

The Debtors prepared the MOR with the assistance of the Debtors’ independent contractors, advisors, and professionals. The MOR was prepared solely for the purpose of complying with the reporting requirements established by the United States Trustee Program (*see* <https://www.justice.gov/ust/chapter-11-operating-reports>).
